- ♦ Largest exploration and production company in Pakistan's oil and gas sector
- ♦ Largest exploration acreage in Pakistan, covering around 38% of Country's total acreage awarded as at December 31, 2020
- ♦ Largest portfolio of net hydrocarbon reserves in Pakistan:
  - 44% of oil (as at June 30, 2020)
  - 37% of gas (as at June 30, 2020)
- ♦ OGDCL during July December 2020 contributed around 47%, 28% and 36% towards Country's total oil, natural gas and LPG production respectively
- ♦ Average daily net saleable crude oil, gas and LPG production during the reporting period was 36,423 barrels, 856 MMcf and 778 Tons respectively
- ♦ Remaining Recoverable Reserves on net basis (As on December 31, 2020)
  - 394 MMBOE on 1P basis (Oil 30 and Gas 364)
  - 797 MMBOE on 2P basis (Oil 87 and Gas 710)
- ♦ 115 OGDCL D&PLs 77 Operated and 38 Non-Operated leases
- ♦ Presence in and knowledge of all four (4) provinces in the Country
- ♦ Nine (9) wells spud and four (4) new oil and gas discoveries made during the period under review

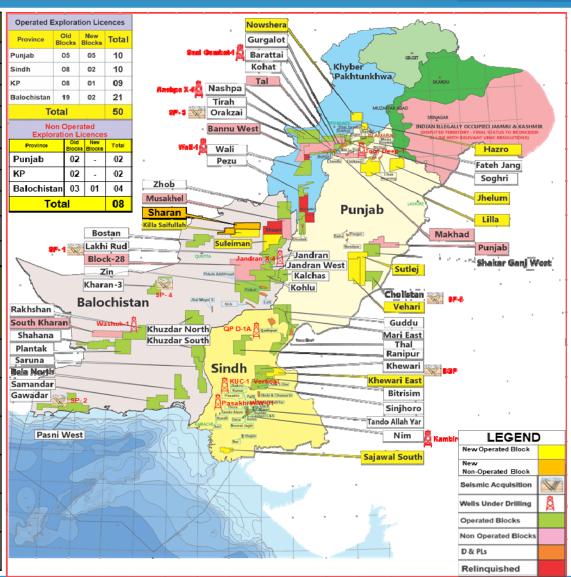

#### Financial & Operational Performance

Half Year (July – December 2020)



- ♦ Net sales revenues of Rs 110.980 billion
- ♦ Oil average net realized price of US\$ 38.81/bbl as against US\$ 54.39/bbl during corresponding period last year
- ♦ Gas average net realized price for natural gas sold was Rs 377.93/Mcf as against Rs 360.24/Mcf during corresponding period last year
- ♦ LPG average net realized price of Rs 62,826/Ton as against Rs 63,174/Ton during corresponding period last year
- ♦ Operating profit margin and net profit margin were 47% & 38%, respectively
- ♦ Earnings per share of Rs 9.82
- ♦ Second interim cash dividend of Rs 1.60 per share



#### **Operational Update - Exploration**

- ♦ As at December 31, 2020, OGDCL operated in 43 Exploration Blocks (19 blocks with 100% share and 24 blocks as operated JVs) covering an area of 77,591 sq. km. Moreover, the Company was provisionally awarded 11 new exploration blocks (10 operated and 1 non-operated) in January 2021.
- ♦ Acquisition of 1,715 Line km of 2D and 156 sq. km of 3D seismic survey
- Nine (9) wells spud, comprising six (6) exploratory/appraisal, one (1) development and two (2) re-entry/side track wells
- ♦ Exploratory efforts yielded four (4) new oil and gas discoveries; Togh Bala-1, Siab-1 (Samanasuk) and Siab-1 (Lumshiwal/Hangu) in district Kohat, KPK province and Lakhi Rud X-1 district Musa Khel, Balochistan province

# **Operational Update - Production**



♦ OGDCL being the national flagship of the Country's E&P sector is making all out efforts to play a pivotal role in enhancing the energy security of Pakistan. In this context, the Company during July - December 2020 contributed around 47%, 28% and 36% towards Country's total oil, natural gas and LPG production respectively.

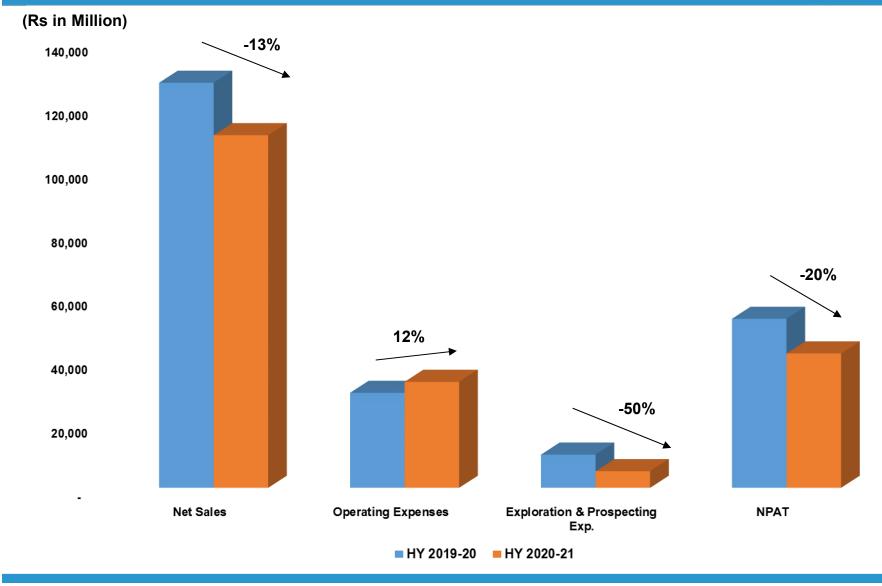
