## DISCOVERY OF GAS CONDENSATE AT TOGH WELL #01

By the Grace of Almighty Allah, the Joint Venture of Kohat E.L comprising OGDCL as Operator (50%), MPCL (33.33%) & SEL (16.67%) has discovered gas & condensate from its exploratory efforts at well Togh # 01, which is located in District Kohat, Khyber Pakhtunkhwa Province. Togh well # 01 was drilled and tested using OGDCL's in-house expertise in consultation with Kohat Joint Ventures MPCL and Saif Energy Ltd. The well was drilled down to the depth of 3200

Meters. Hangu formation has been tested and flowed 4.1 MMSCFD of gas and 50 BPD of condensate through 32/64" choke at wellhead flowing pressure of 760-823 Psi. The discovery of Togh well # 01 is the result of aggressive exploration strategy adopted by the Kohat Joint Venture. It has opened a new avenue and would add to the hydrocarbon reserves base of the country.




OGDCL has commenced drilling operations for first shale gas well, KUC-01 in District, Hyderabad, Sindh from 14th December, 2019. OGDCL has technically planned to drill KUC-1 well in two phases. The first well is planned to be drilled in vertical section and frac operations will be carried out after reservoir evaluation. Based on the outcome of the reservoir evaluation and frac job, further technical evaluations will be carried out that will decide upon entering the second phase which will include drilling a horizontal well section and further frac operations.

This is the first well being drilled to explore unconventional shale gas and estimated chance of success (COS) for commercial hydrocarbon production at this point in time is about 10%. OGDCL has the complete operatorship of the well. KUC-01 is a pilot shale gas project and one of the key objectives is to gather maximum information on prospects of shale gas and to ascertain the possibilities of shale gas development in Pakistan.

# Company Declares Financial Results for 1st Quarter FY 2019-20 (ended 30th September, 2019)

The Board of Directors of the Company in a meeting held on 25th October, 2019 announced the financial results for the 1st quarter of 2019-20 (July-September). The Company's net sales revenue was registered as Rs 66.204 billion and profit after tax stood at Rs 27.316 billion translating into earnings per share of Rs 6.35. The Board of Directors announced first interim cash dividend of Rs 2.50 per share. During the period, the Company paid Rs 12.602 billion on account of taxes.

## Dakhni & Soghari - HAZOP - Well site and Gathering System

Hazard and operability study (HAZOP) is a structured and systematic examination of a complex planned or existing process in order to identify and evaluate problems that may represent risks to personnel or equipment. The intention of performing a HAZOP is to review the design and engineering issues.

HAZOP of Dakhni wellhead to gathering system was carried out at M/s Petrochemical Engineering Consultants (PCEC) Karachi on 4-5 December 2019, which was attended by PE&FD and Process Engineers from Dakhni Site.

Three categories of wells were considered during this study which included high-pressure sour wells (Soghri & Jand-1), low pressure sour wells (Dakhni # 01,03,08,12) and sweet wells (Dakhni Deep-1 & 2). High & low scenarios of flow, pressure, and temperature were discussed based on P&IDs & modifications were recommended.

This HAZOP exercise would create safe working conditions at field and plant side in Dakhni field under OGDCL management's vision for overall value addition under improved engineering practices and investment in human resource training.

### Improve Your Critical Thinking Skills


To make good decisions, it's important to think critically. And, yet, too many leaders accept the first solution proposed to them or don't take the time to evaluate a topic from all sides. To guard against these mistakes, there are several things you can do to hone your critical thinking skills. First, question your assumptions, especially when the stakes are high. If you're coming up with a new business strategy, for example, ask: Why is this the best way forward? What does the research say about our expectations for the future of the market? Second, poke at the logic. When evaluating arguments, consider if the evidence builds on itself to produce a sound conclusion. Is the logic supported by data at each point? Third, seek out fresh perspectives. It's tempting to rely on your inner circle to help you think through these questions but that won't be productive if they all look and think like you. Get outside your bubble and ask different people to question and challenge your logic.

#### From the World of Medicine

## Cracking knuckles can cause arthritis



Hearing that satisfying or annoying, pop in your knuckles can't be good for you, right? Well, it may not be good for you, per se, but experts agree that it doesn't lead to arthritis. That "cracking" sound is actually caused by the bursting of gas bubbles in the finger's joint fluid, according to Harvard Health Publishing. One study published by the journal Hand Surgery and Rehabilitation also found that knuckle-cracking didn't negatively impact grip strength, something that had been an earlier concern. That said, there have been rare cases of tendon injuries and joint dislocations related to attempted knuckle-cracking.



Do you have your mom's button nose? Did your dad pass on the curse of sneezing in bright sunlight? And where did your baby's red, curly hair come from? The science of genetic inheritance is complicated. It's nearly impossible to tease out exactly where each of your traits came from. Most traits are influenced by many different genes and you inherit some from each parent.

There are three main ways you can inherit traits from your parents. First is through a dominant gene - if you inherit a dominant gene you will develop that trait. Take eye colour, for example. If either of your parents have brown eyes, you likely will have brown eyes as this is a dominant trait. Second is through a recessive gene - both parents have to have the recessive gene for you to have that trait. For instance, if you have blue eyes then both of your parents must carry a gene for blue eyes, even if their eye colour isn't blue. Lastly, there are X-linked traits which are found only on the X chromosome and are passed on through the mother.
