- 1. OGDCL intends to acquire Detailed Design for External Emergency Exit Stairs and thereafter Supply, fabrication & installation / erection of the approved Design Stairs inclusive of all allied works and materials, its maintenance during Maintenance / Defects Liability Period.
- 2.0

2.1 Technical & Financial proposals shall reach to this office on the date and time mentioned in the advertisement Technical proposals will be opened on the same day in presence of the participants while financial proposals will be kept sealed in safe custody till evaluation of the technical proposals. The financial proposals of the technically responsive bidders will be opened on the date and time communicated later on after evaluation of the technical proposals while bids of the technically non-responsive bidders will be returned un-opened. Technical evaluation will be as per criteria given in this invitation subject to any changes made by management at any stage prior to opening of bids. The bid found to be the lowest evaluated responsive bid shall be accepted.

The Terms of Reference for both the Design stage and thereafter Supply, Fabrication & Installation / erection stages are as under.

A. <u>DESIGN STAGE.</u>

3..0 SITE VISIT, TECHNICAL REQUIREMENTS AND PRELEMINARY DESIGN.

3.1 You will be required to conduct a visit to the project area i-e OGDCL House. The building is comprised of 02 basement, 01 lower ground, 01 ground floor and 16 floors above ground.

- 3.2 You will be provided related drawings of the OGDCL House building in this regard. You have to conduct necessary survey of the site with regard to this project and take all measurements, levels etc for design purpose.
- 3.3 The design shall be done so that the load of the stairs shall be distributed to different columns / beams and points. Single column may not be stressed / loaded beyond its general capacity.
- 3.4 National standards / codes, Building Codes of Pakistan Safety Provision 2016 and applicable HSEQ requirements shall be followed in determining the parameters for designing of the stairs and its installation.
- 3.5 Data regarding manpower floor wise will provided when required.
- 3.6 The materials used in this work need to be fire resistant as per HSEQ requirements. It shall not be less than 2 hours fire resistant.
- 3.7 Contractor shall present various option(s) with respect to Structural Stability, Fire resistivity and cost factor.
- 3.8 Technical requirements shall be in compliance to relevant codes but not limited to the following:-
 - 3.8.1 The design shall be based on the requirement of relevant ASTM codes as mentioned in the BOQ, national building codes for high rise steel structures, CDA regulations / guidelines, Building Codes of Pakistan Fire Safety Provision 2016 and prevailing HSEQ requirements. All the members shall be critically designed for any local failure or global failure of the structure considering all aspects of design but not limited to compression, tension, shear, flexure buckling, settlement, anchorage, fasteners and welding strength / capacity for required loads, resistivity against horizontal loads in the form of wind, seismic load, etc.
 - 3.8.2 The Lowest Evaluated Responsive bidder (LERB) shall submit preliminary drawings for salient features including weight, layout plans, elevations, 3D view and other features as per TOR.
 - 3.8.3 The Lowest Evaluated Responsive bidder shall submit complete design, floor wise drawings, elevations, computer model showing all structural members / elements details with calculations of loads, stress, moments, results etc, as per TOR. A color 3D view will also be required.
 - 3.8.4 It is to be noted that the columns required away from the building shall be placed on the exterior RCC wall of the basement considering the load transfer mechanism based on appropriate design to be carried out by the lowest bidder.

- 3.8.5 All members of stair must be constructed / erected upto outface of retaining wall of the basement and no load bearing to be erected on roof slab of basement.
- 3.8.6 The anchor bolts conforming to ASTM 307-A and anchorage mechanism to meet the required pulling and shear strength shall be designed by the lowest bidder in compliance of HILTI or equivalent epoxy as approved by the engineer-in-charge / employer.
- 3.8.7 The area at ground between exterior RCC walls of the basement and the proposed exit is the slab of the basement and no columns shall be placed directly on the slab without proper design and approval thereof. It is encouraged to avoid placement of columns on slab of the basement. The sketch of the proposed location is attached.
- 3.8.8 The base plates, end plates, connection plates shall be in compliance to ASTM A-36 and as per design approved by the employer.
- 3.8.9 The lowest bidder is required to confirm their sections as per design load calculations, computer models with results and ASTM & National Codes requirements. The responsibility for the final design shall rest on the bidder. The design / drawings / calculations to this effect shall be vet by the consultant / Design Engineer (duly registered with PEC) engaged by the contractor. The contractor shall submit a certificate, duly signed by him & his consultant / Design Engineer stating that the design submitted by him is in accordance with ASTM & National Codes, Building Codes of Pakistan Fire Safety Provision 2016, CDA requirements, and is sound, safe and economical as per industrial practice.
- 3.8.10 Bracing and flight beams may be designed in compliance to the ASTM & National Codes and CDA requirements.
- 3.8.11 The stairs / Tread and platform shall be grating of the ¼" thick X 2" wide steel strips / member with the spacing of ½" along the tread and with spacing of 3" across the step as shown in the attached picture / drawing.
- 3.8.12 Railing shall be made of 2" MS pipe hand rail supported by vertical pipes 2" dia and the space between the top rail and the flight beam shall be divided in to four portions by horizontal MS pipes of 1" dia. The railing shall be properly welded to the flights at every third step. It will be covered with fire resistant coating /paint. A picture or drawings is attached.

- 3.8.13 The horizontal beams will be anchored to the RCC walls of the buildings as required. In this regard alternate options of the lowest bidders, if any, will also be considered before approval of the final design by the employer.
- 3.8.14 A canopy of the approved design at the top of the stairs to protect against rain shall also be provided and installed by the lowest bidder.
- 3.8.15 The bidders are required to accept the technical requirements and a conformance certificate to this effect shall be submitted along with his bid. A financial bid as per these technical requirements and BOQ attached in TOR may also be submitted as per this bidding procedure.
- 3.9 Preliminary design / Initial Draft to be submitted by the lowest bidder after award shall include the following.
 - 3.9.1 Conceptual Plan of the External Emergency Exit Stairs showing relevant details.
 - 3.9.2 Preliminary design and drawings for all floors of external stairs.
 - 3.9.3 Orientation and placement plan.
 - 3.9.4 Preliminary drawings of all members showing relevant dimensions as required.
 - 3.9.5 The availability of the material including all members and its fabrication. The bidders shall also clearly mention in their technical proposal their availability and fabrication for all the materials for the project.
 - 3.9.6 The loads calculations to be considered in design including Environmental / seismic loads.
 - 3.9.7 Drawings showing details of Foundations of the supporting Columns, Columns, beams at all levels, bracings, platforms at all levels, Plates, railing, anchorage with members of the existing building.
 - 3.9.8 Architectural plans, elevations, perspective views and X-Sectional details of stairs.
 - 3.9.9 Workplan for installation and erection of the proposed stairs and Push Bar Doors.

- 3.9.10 The entire design shall be in harmony with National Codes, Pakistan Building codes – Fire Safety Provision 2016 and applicable HSEQ requirements.
- 3.9.11 Material list element wise / BOQ of the entire project for our record and future requirement.

4.0 DETAILED DESIGN.

After approval of the preliminary design / Draft Design by the OGDCL, Detail design will be carried out by the lowest bidder / contractor and will include but not limited to the following,

- 4.1 Complete Design Report showing all calculations, loads, stress and moments.
- 4.2 Based on approved preliminary drawings / draft drawings, detailed drawings showing details of Foundations of the supporting Columns, Columns, beams at all levels, bracings, platforms at all levels, Plates, railing, anchorage with members of the existing building.
- 4.3 Based on approved preliminary drawings / draft design, detailed architectural plans, elevations, perspective views and X-Sectional details of stairs.
- 4.4 Layout Plan showing required bench marks, if any.
- 4.5 Plan, X-Sections and Mechanical input of special members, if any.
- 4.6 BOQ/ Materials list / drawings showing quantities of major items.
- 4.7 Electrical drawings showing provision of electricity and electrical details including earthling of the stairs.
- 4.8 Details of Push Bar Doors.
- 4.9 Certificate of compliance of National Codes, Building Code Pakistan Safety Provision 2016 and applicable HSEQ requirements for External Emergency Exit Stairs, duly signed by contractor and his consultant / Design Engineer, registered with PEC.
- 4.10 Necessary approval from line agencies like CDA and other departments shall be responsibility of the bidder, however, any fee / payment involved in such process shall be paid by OGDCL.
- 4.11 The Contractor, as part of the technical evaluation criteria, must provide CV of the HSEQ professional who will coordinate with OGDCL Admin Department and HSEQ Department during Installation phase. Further the contractor will also provide previous HSE record with other department. The contractor will provide details of his consultant / Design Engineer registered with PEC along with his profile / CV showing relevant works.

5.0. PROVIDE & SUPPLY, FABRICATION AND NSTALLATION / ERECTION.

_After approval of Detailed Design, Supply, Fabrication and Installation / Erection of Stairs will be carried out by the contractor, including but not limited to the following;

5.1 Provide & Supply of the required material as approved by the employer in the quantities as required for the project. The receipt showing quantities purchased and reached at workshop for fabrication along with Material Testing Certificate shall be submitted to employer.

- 5.2 Fabrication of all parts as per drawings shall be executed in the workshop of the contractor. All parts shall be prepared at workshop complete in all respect to avoid / minimize welding and other fire related works at site. It will minimize risk and fire incidents. Further all members shall be galvanized and coated with intumescent fire resistant coating as per BOQ and requirements.
- 5.3 The Fabricated members with necessary allied items shall be transported to site in the designated hours and to the allotted area in the premises of the OGDCL House.
- 5.4 Members joining which are required at ground to be carried out at the area designated for them.
- 5.5 Lifting of all material / members shall be done after working hours with prior approval and under supervision of the Engineer Incharge, Administration / Maintenance representatives and HSEQ representative.
- 5.6 Technical Specification metioned in TOR / BOQ and finalized in the detailed design stage shall be followed. The approved methodology shall accordingly be followed to avoid any mishap.
- 5.7 Work permit to be obtained prior to starts of the work as per HSEQ Department requirement.
- 5.8 Contractor shall be responsible for any damage, injury and mishap, both in financial terms and human loss, if on his part.
- 5.9 The activities like drilling, boring etc which creates nuisance shall be done after working hours or on holidays. The environment of the office shall be maintained workable.
- 5.10 Proper layout according to drawing and vetted from OGDCL Site In-Charge.
- 5.11 All construction materials required for civil works (including but not limited to dismantling, repairing, reconstruction and reinstatement) at site and Fabrication works at workshop will be the responsibility of the contractor.
- 5.12 Provision of skilled, unskilled labour and all type of transportation will also be at the part of Contractor.
- 5.13 Contractor will be responsible for complete Installation of External stairs including all types (mechanical, electrical and civil) works.
- 5.14 After the Installation, a joint confirmation visit will be carried out to vet the stairs according to the drawings.

- 5.15 The contractor will maintain the external stairs after Installation for one year during maintenance period. The maintenance expenditure will be at the part of contractor.
- 5.16 The contractor will prepare a Handing and Taking documents showing the quantity of all material installed.
- 5.17 To check and verify the quality of works, a third party inspection (TPI) will be engaged by OGDCL independently. The terms of TPI will be set and executed with the firm hired separately.
- 5.18 Upon verification by the Engineer-in-charge, the site will be taken over, however, the Contractor will be responsible for any repair and maintenance, if required after maintenance period and on payment.

6 **COMPLETION PERIOD.**

- 6.1 Completion Period for Design stage will be 30 Calendar days after issuance of Work Order. The time taken by OGDCL for approval of preliminary and detailed drawings shall not be included in these 30 days and shall be on OGDCL part.
- 6.2 Completion Period for Installation stage will be 270 Calendar days after giving go-ahead for Installation.
- 6.3 The contractor will submit Detailed Drawings and design report within Completion Period for design stage.
- 6.4 OGDCL will accord approval and give go-ahead for installation within 30 calendar days or within time as required by OGDCL but this time will be at OGDCL part and not more than 90 calendar days.
- 6.5 The Contractor will intimate OGDCL for joint confirmation visit and will be taken as Completion date, if installation is reported satisfactory.
- 6.6 The Defect Liability Period will be one year and will be reckoned from the date of Completion.

7 **<u>PAYMENT.</u>**.

The payments are to be made in 02 stages.

7.1 Design Stage

- a. Upon approval of Detailed drawings = 100 % of quoted Design / Consultancy stage fee by Contractor.
- 7.2 Mobilization Advance @ 10 % of contract price exclusive of cost of designing shall be allowed on the request of the contractor after approval of detailed design by employer, against the bank guarantee from a scheduled bank of Pakistan, which shall be recovered as percentage of progress in running bills.
- 7.3 Provide & Supply, Fabrication & Installation Stage

For this stage the contractor will propose the payment schedule and will be included in contract agreement after approval by OGDCL.

- 7.4 Retention Money shall be @ 05 % of each bill upto 2.5 % of the Contract Price and 50 % will be subject to release on proper Handing & Taking and rest on Completion of Maintenance Period.
- 7.5 Performance Bond shall and 50 % Retention money both shall be retained till completion of Maintenance Period / Defects Liability Period.

8.0. **PENALTY.**

8.1 Any delay without any valid reason will be considered as Liquidated Damages and charged as 0.1 % of the bid price per day max upto 10 % of the bid price.

9.0 OTHER CLAUSES.

- 9.1 You will be required to present your design / options to OGDCL management, as advised.
- 9.2 If required, you will be bound to provide any other documents without any additional charges.
- 9.3 The drawings and other documents prepared in connection with the project shall be the property of OGDCL and copyrights therein shall vest with OGDCL.
- 9.4 Additional services if required (other than the services mentioned in the scope of services) will be paid on the rate mutually agreed by both the parties hereafter.
- 9.5 Earnest money @ 01% of bid price must accompany your bid and shall be in the form of DD,CDR, SDR, Call deposit, bank guarantee and Pay order

and in favor of OGDCL Islamabad. Earnest Money of unsuccessful bidder shall be released as per procedure however earnest Money of the successful bidder shall be released upon submission of Performance Bond in Shape of Bank Guarantee or Payorder, CDR, SDR and Demand Draft.

- 9.6 Performance bond shall be in the Shape of Bank Guarantee @ 05 % of the bid price and valid till Completion of Defect Liability Period. Performance Bond to be provided by the successful Contractor within 14 Days of issuance of LOI. Performance Bond will be liable to forfeiture under default of the Contractor.
- 9.7 The Contractor shall insure, in the joint names of the Contractor and the Employer, against liabilities for death of or injury to any person or loss of or damage to any property (other than the Works) arising out of the performance of the Contract. This 3rd Party liability will be in form of Insurance Guarantee @ Rs.500,000/- per Occurrence with unlimited number of occurrences and will be provided by the Contractor after taking over the Site.
- 9.8 In Case of any dispute, Suspension of work and default, the PEC standard procedure shall be followed and decision of MD/CEO OGDCL shall be final and binding on both the parties.
- 9.9 No escalation shall be allowed on account of fluctuation in market rates.
- 9.10 No damage to men and property of the contractor at site for any reason shall be compensated and the cost quoted shall be final for the desired specifications. Final cost is subject to desired specifications or material.
- 9.11 OGDCL may terminate the contract at the design stage or earlier or later without entertaining any claim of the contractor on this account. Payment for the design work executed and verified by OGDCL will considered.
- 9.12 No claim on account of any delay in approval of design on OGCL part shall be entertained. The contractor shall be bound to complete the executions stage (S/F & Installation) as per the tender documents as soon as approval is conveyed to him, even in case of delay in approval of design at OGDCL part.
- 9.13 No claim on account of any reason shall be considered.
- 9.14 Secured Advance @ 75 % of material cost, against materials brought at site shall be paid after approval of the competent authority subject to indemnity bond.

- 9.15 All bills shall be paid, as per OGDCL procedure and in time as required by OGDCL and no interest for delay in payment of running bills or Final bill is applicable.
- 9.16 GST and ICT Sale Tax, if applicable, shall be borne by OGDCL, however contractor will provide Sale Tax Invoice and Annexure-C (duly paid) with each running bill. The Sale Tax amount will be reimbursed with the running bill or with the manner as OGDCL practice. The bid price is excluding GST and ICT Sale Tax.
- 9.17 In case the weight of final design submitted by contractor and approved by OGDCL is less by more than 10 %, then the contractor has to accept the weight for payment. No claim for extra payment due to less weight shall be admissible.

10.0 **PROCUREMENT PROCEDURE.**

The following procedures shall be permissible for open competitive bidding,

Single stage - two envelope procedure.-

- The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal;
- (ii) The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion;
- (iii) Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened;
- (iv) The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened;
- (v) The procuring agency shall evaluate the technical proposal as per attached technical evaluation criteria sheet, without reference to the price and reject any proposal which does not conform to the specified requirements;
- (vi) During the technical evaluation no amendments in the technical proposal shall be permitted;

- (vii) The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
- (viii) After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only. The financial proposal of the technically non-responsive bidders shall be returned un-opened to the respective bidders.
