Terms of Reference (TOR)/Schedule of Requirement (SOR)

- The bidder must have at least 02 Nos. Production Plants for Liquid Nitrogen (LN) one in North (Punjab or KPK) and the other in South Region (Sindh or Balochistan) with adequate production and Storage facilities.
- The Bidder must have at least 03 years of experience in production and supply of LN and must provide the list of their clientage.
- The Bidder should ensure temporary storage facility of 30,000Ltrs LN capacity for supply in Potohar region for customer convenience.
- The Bidder will ensure that their LN Production Plants should have the backup power facilities.
- Purity of LN must be 99.99% along with quality assurance certificate and the purity of LN will be checked by OGDCL Representative randomly throughout the contract.
- Bidder's Plant ISO certification.
- The Contractor shall always maintain sufficient stock and ensure lifting/ delivery of Liquid Nitrogen requirement on as and when required basis within maximum 48 Hrs on written notice from the Company.
- The Contractor shall provide vacuuming facilities for Company's vessel both at Contractor's and Company's sites.
- The Company shall place Purchase Orders on the Contractor from time to time on "As and When Required" basis as per agreed rate mentioned under heading "Pricing Terms" hereunder.
- If desired, the Contractor shall provide the Transportation Fleet (Tankers) on Company's request on "As and When Required" basis as per agreed per liter rate mentioned under heading "Pricing Terms" hereunder.
- Bidder's LN Plant visit during technical evaluation.
- Bidder's technical support team for customer LN vessel check-up, trainings and handling of cryogenics.
- Payment after delivery of LN.
- Flat rate for three years.

- Bid Bond Value: Rs. 3,040,000.00
