### TERMS OF REFERENCES (TOR) FOR SUPPLY OF SAFETY SHOES TO DAKHNI PLANT

- 01. Bidder must have at least 5 years of experience in supply of Safety Shoes. Verifiable list (supported by documentation such as purchase orders) must be provided for the supply of safety shoes, besides unpriced copy of contract, purchase order with name and full contact details to be provided in technical bid.
- 02. Sample(s) of offered item(s) shall be provided with your proposal and for each quoted item at the bid opening date and time. No bid will be accepted without samples.
- 03. Qualified bidder will be bound to provide material as per approved sample.
- 04. Required sizes with quantity will be provided at the stage of issuance of purchase order.
- 05. Without any extra charges, rejected items will be replaced/exchanged by bidder.
- 06. Payment will be made after 100% delivery, subject to acceptance of material by inspection committee at Dakhni Plant.
- 07. Delivery period for material is 60 days from the date of issuance of Purchase order.
- 08. Any variation in quantity at the time of order placement will not change the unit cost of material.
- 09. The material will be delivered at Dakhni Gas Processing Plant Tehsil Jand District Attock, the delivery charges to Dakhni Plant to be borne by the supplier / bidder.
- 10. OGDCL reserves the right to increase or decrease the quantities or may cancel any or all items shown in the SOR without assigning any reason thereof.
