INSTRUCTIONS TO THE BIDDERS/ TERMS & CONDITIONS:

- 1. The quantities of indented material are tentative & can be increased/ decreased according to the requirement.
- Delivery period of the whole consignment will be <u>150 Days</u>, however the supplier will have to provide the indented chemical in 02 equal consignments. First consignment must be delivered within 60 days after receiving the Purchase Order (PO) from OGDCL, while second / last consignment within next 90 days.
- 3. Minimum Shelf life of the quoted product should not be less than 03 years.
- 4. Technical specifications sheet of the quoted product duly filled in must be enclosed with the technical bid.
- 5. The bidder has to provide the complete name and address of Manufacturer with brief history of manufacturing the quoted product.
- 6. An authority letter in original issued by the manufacturer for allowing the bidder to quote their product for this particular tender enquiry, duly signed/stamped, must be attached with the technical bid in case the bidder is not manufacturer.
- 7. All submitted bids will be evaluated strictly on the basis of previous performance (supply record) of bidder / manufacturer, failing which will lead to disqualification of Bid thereof.
- The bidder must have to provide the 1.0 Litre sample of the quoted product. Without the submission of the product sample bid will not be entertained.
- 9. Prior to the supply of the material, the supplier will be responsible for carrying out the inspection of the material if desired by the indenting department.
- 10. Material will be accepted after the physical inspection & lab evaluation report of the representative sample drawn by the inspection committee from the material delivered at required locations.
- 11. On receipt of the material, if it is found substandard after testing / use, then the supplier shall have to lift the entire rejected consignment and replace the substandard material with the material conforming to the tender specifications at his own cost within one month.

PACKING & INSTRUCTION TO BIDDER

PACKAGING:

The chemical should be packed as 170-210 Litres per drum in non-returnable leak proof, sealed, export quality mild steel drums having tare weight 20 -22 kg /drum, hermitized & corrosion resistant. Moreover these drums should be palletized as 04 drums per wooden pallet, wrapped with thick polythene sheet and tightly strapped. The packaging of the required chemical should be of international standards and capable to safe transportation during road journey from manufacturing facility to OGDCL stores & well sites and to withstand prolonged weather conditions at the storage points and at the well sites / locations.
