- 2- Bidder is responsible for any type of material, software, software integration and services required for the installation and successful commissioning of L-73 controllers.
- 3- Bidder is responsible for removal of already installed L-71 controllers in Node-I (main+redendent) & Node-II (main+redendent) installed at Dakhni Plant and installation of the new L-73 controllers in the nodes I(main+redendent) & Node-II(main+redendent) along with all its accessories and required terminations & programming to accommodate all the already connected I/O's and in addition of more than 50 new I/O's.
- 4- A!! type of variation in existing logic & HMI if deemed necessary is in bidder scope.bidder is responsible to add the new logic for newly includede items (more than 50 items).
- 5- After award of purchase order successful bidder will consider this project as turn key project. ogdcl will only provide the electricity.
