INSTRUCTIONS TO THE BIDDERS/ TERMS & CONDITIONS:

- Delivery period of the Quoted Item is <u>90 Days</u>, however, the supplier will have to provide in two equal consignments. Half quantity at both locations must be delivered within 45 days after issuance of LPO, while next half quantity after clearance of 1st consignment.

COMMON WATER PROOF TEST FOR TARPAULINE:-

PS 1450-1986

Forming of cone by folding, pressing and creasing 300*300 mm, piece of material, and fit it on open ring .Fill the cone with 400ml water and allow it to stand as such at room Temperature for 18 hrs. There shall be no leakage of water from cone and outer surface Shall not be showing sign of wetting.
