#### 1. Introduction:

Skid Mounted Crude storage tanks are required for OGDCL Production Fields. The required quantity is 20 Nos. with cap. 500 BBLs each the crude to be handles shall be of API gravity 20-60 Deg.

#### 2. Scope of work:

Bidder has to comply all the following in its technical proposal and is liable to provide the same.

- i. Crude storage tanks shall be constructed in accordance to attached drawing in all respect. All the fitting and pipe line material shall be in accordance to ASME/ANSI Standards and all material shall be in accordance to ASTM Standard.
- ii. Internal FRP coating @ 3mm thickness, to all the surfaces (bottom, side walls and ceiling)
- iii. External coating for all the surfaces
  - 1 coat of zinc rich epoxy primer at 50 microns dft (Final color shall be approved by OGDCL)
- iv. All the nozzle connections of the tank shall be equipped with gate valve, gasket, stud nut and companion flange with respect to design size, class rating etc of the nozzles. Bidder to confirm the brand of the gate valves. Euorpean or USA brands shall be acceptable. Material of the valves must be compliant to the specs of crude oil.
- v. Bidder to provide calibration chart of each tank. Calibration shall be carried out from reputed third party company having at least 05 years experience of working such a jobs. In this regard bidder has to confirm the name of third party company along with detail in Technical Proposal.
- vi. Dip rod (solid brass bar of hexagonal cross section type size 3/4 inch Length shall be as per tank height + Hieght of dip Hatch Nozzle + 12" extra ). 02 Nos. laminated calibration chart duly verified and stamped from TPI shall be provided for each tank.
- vii. Hydro testing and integrity of FRP coating of the tank shall be carried out in the presence of OGDCL professional as per prevailing standard procedure.

#### 3. Terms and Conditions

The prospective bidder has to fulfill following requirements and accordingly provide the requisite documents/certificates along with the technical proposal. Compliance is mandatory.

i. Bidder must have minimum 05 years experience of construction of crude storage tanks. Bidder has to submit last 05 years details of the

same type of projects as per following formats along with copies of purchase orders.

- a. Name of company
- b. Size and capacity of the tanks
- c. Nature of fluid to be stored
- d. Address and contact # of the company
- ii. Bidder to submit details of its manufacturing facility mentioning address, contact No. and Person name.
- iii. Bidder should be Tax Registered firm and provision of NTN certificate is mandatory.
- iv. Bidder must be ISO certified and acquire ISO 9001-2008 valid certificate. Bidder to submit the copies of certificate.
- v. Only PEC C-4 registered firms are acceptable. Bidder has to submit copy of valid requisite certificates.
- vi. The prospective bidder must have of annual turnover of Minimum 50 Million. For verification last 03 years audit reports of years 2015-16, 2016-17 and 2017-18 to be submitted along with technical bid. In case of failure to provide along with Technical bid, bid shall be rejected.
- vii. Bidder has to confirm acceptance that payment shall be made after delivery and successful inspection of material at OGDCL site. Part Delivery part payment shall be acceptable.
- viii. Bidder has to confirm that OGDCL has the right to visit its facilities at any working day with prior information to check the status of the consignment.
  - ix. Bidder has to confirm that manufacturing faults OR non-compliance to OGDCL Tender clauses pointed out by OGDCL at any stage before, during commissioning or after commissioning during warranty period will be rectified by the contractor at its own cost.
  - x. Bidder must have its own manufacturing Facility. Outsourcing of whole job would not be allowed.
  - xi. Bidder should not be black-listed by any Governmental, Semi-Governmental Organization.
- xii. All kind of Loading, Transportation and Off-loading to OGDCL Site would be responsibility of Supplier.
- xiii. In case of joint venture, copy of contract on judiciary stamp paper should be provided in technical bid clearly mentioning the lead partner. The lead partner should fulfill "Requirements for bid submission" and from Para 3.i to 3.xii.

#### 4. Delivery Period.

Delivery period shall be 06 Months after issuance of LPO. Bidder has to

arrange to deliver all the tanks at their own transport as per following locations.

- a- 10 Nos at Tando Alam Oil Complex which is 20-30 kms away from Distt. Hyderabad
- b- 10 Nos. at Chaknaurang Oil Field which is 20-30 Kms away from Chakwaal.
