1. Firm country of origin for each part to be provided in technical bid which cannot be changed later on at any stage.
2. If bidder found any ambiguity in part nos., it should be cleared prior to bid opening date
3. Parts must be in original OEM Packing and must be new & free from any defect and must have standard OEM warranty/guarantee. Bidder will submit GD / Import documents with the Invoice.
4. Bidders to submit their company profiles, proof of 05 years' experience for supply of CAT spare parts (i.e Previous Purchase Orders) along with technical bids.
5. In case of superseded parts, then supporting documentation from OEM must be provided along the technical bid.
6. Only genuine CAT spares are required. In case of equivalent parts quoted, certificate from CAT (OEM) must be provided with the technical bid, clearly mentioning that the quoted spares are same in form, fit, function etc. as of the original requirement.
7. Delivery period is 90 days from issuance of P.O.
8. Delivery Location: FOR, Qadirpur Plant
9. Detailed inspection of delivered material will be carried out at site after delivery. Payment will be made after complete delivery and complete inspection /acceptance at site. Partial Payments will not be made, in any case.
