TERMS OF REFERENCE (TOR):

OGDCL intends to procure fire detection and suppression system for new central control room (CCR-hall #1) & marshaling panel room (hall#2) at Dakhni Gas Processing Plant according to following TORs:

- 1. Pre bid Dakhni plant visit is mandatory to understand the complete scope of work.
- 2. Enlisted material in indent is the minimum requirement of the system however for accomplishment of fire detection & suppression system it may be enhanced but financial bid evaluation shall be done on offered prices of complete system alongwith installation and commissioning service charges.
- 3. Bidder is responsible for any type of material (hardware & software (if any) for the installation and successful commissioning of complete system.
- 4. After award of purchase order successful bidder will consider this project as turnkey project. OGDCL will only provide the electricity.
- 5. Bidder must follow the work order & work permit as per applicable at Dakhni Plant.
- 6. Bidder will perform the work as per standard procedures however during performing the job, any damage to OGDCL property occur due to bidder fault then bidder has to pay as per actual.
- 7. Operational Training to OGDCL site team after successful commissioning, at least one complete session. Training shall consists of:
 - · Control system operation
 - Trouble procedure
 - Abort procedure
 - · Emergency procedure
 - Safety equipment
 - · Demonstration of the system
- 8. Bidder to perform kick off meeting after acceptance of the Purchase order.
- 9. Bidder to provide the JOB COMPLECTION strategy with the technical bid.
- 10. Bidder shall submit layout drawings with their technical bids.
- 11. Bidder must follow the HSEQ rules at Dakhni Plant.
- 12. OGDCL will only provide boarding /lodging of technical persons.
- 13. Payment will be made after the successful completion certificate from PM Dakhni and on verified invoices from plant Manager Dakhni.
- 14. Bidder must not be black listed in any country of the world or in any company in Pakistan.
- 15. Design & gas calculation must be approved by principal.
- 16. Gas must be factory filled by authorized manufacturer/gas provider.
- 17. OEM certifications must be available.
- 18. OEM standard guarantee/ warrantee certificate must be provided with main equipment.
- 19. OEM authorization letter shall be mandatory requirement.
- 20. All mechanical and electrical components shall be tested according to manufacturers recommended procedure to verify system integrity followed by functional test of the system (test procedure shall be recommended by equipment supplier).
- 21. Completion time for installation and commissioning of the system shall not be more than four
- 22. Delivery period for material is 120 days after LPO.
