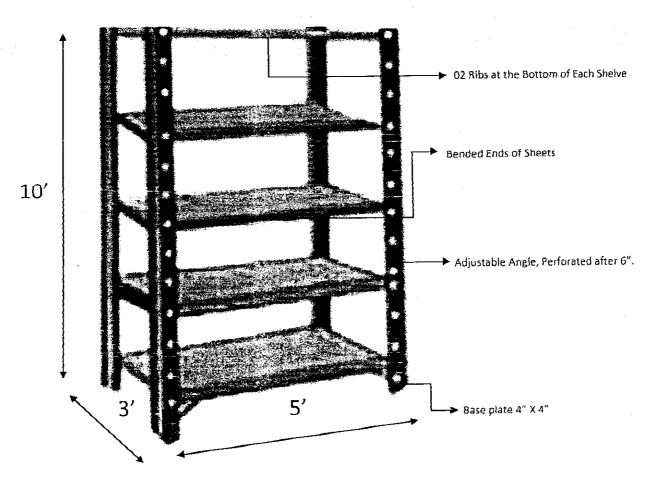

#### Material Rack Size:

- Steel Rack size 10' X 5' X 3' (Height 10', Length 5', Width 3')
- 5 Shelves including Top and Bottom
- Load Bearing Capacity of Rack 2000 kg, load bearing of each Shelf 400 kg.
- Adjustable Angle for pillar ASTM A36, size 3" X 3" X 3.251 MM (105WG) with base plate 4" X 4" X 3.251MM for each pillar. Angle for pillar should be perforated after 6" distance for adjustment of shelve.
- Supporting Sheet of shelve for steel rack should be 14 SWG and must be bended from all ends.
- 02 Ribs in bottom of each shelve, sheet for Ribs should be 3' X 6" X 1/6" (8 SWG),
- Galvanized bolts 08 Nos for each shelf fastening and proper support and grip.
- Adjustable, Rust protection Application (Removed Rust With Power Brush And Apply One Coat Of Rich Red Oxide And Two Coats Of Smoke Grey Enamel Paint)
- Delivery and Installation / Fixation of Racks at Neshpa Oil Field, district Karak, KPK.
- Delivery period 90 days after placement of order.
