INSTRUCTIONS TO THE BIDDERS/ TERMS & CONDITIONS:

- 01. Total Quantity of Tarpaulins to be procured is 150 Nos.
- 02. The quantities of indented material are tentative & can be increased/ decreased according to the requirement.
- 03. The Bidding procedure will be Single Stage & Two Envelope.
- 04. Bids evaluation criteria is technically responsive and financially the lowest.
- 05. **Delivery period of the Quoted Item** is <u>90 Days</u>, however, the supplier will have to provide in two equal consignments. Half quantity at both locations must be delivered within 45 days after issuance of LPO, while next half quantity after clearance of 1st Consignment within next 45 days at both locations.
- 06. All bidders must have to provide 1 M X 1 M sample of the quoted Tarpaulins along with the technical bid. Without the submission of sample bid will not be entertained.
- 07. Delivered Tarpaulins will be accepted after physical inspection and water proof testing at the locations by the inspection committee.
- 08. On receipt of the material, if it is found substandard after testing / use, then the supplier shall have to lift the entire rejected consignment and replace the substandard material with the material conforming to the tender specifications at his own cost within Fifteen (15) Days.

COMMON WATER PROOF TEST FOR TARPAULINE:- PS 1450-1986

Forming of cone by folding, pressing and creasing 300*300 mm, piece of material, and fit it on open ring .Fill the cone with 400ml water and allow it to stand as such at room Temperature for 18 hrs. There shall be no leakage of water from cone and outer surface .Shall not be showing sign of wetting.
