Terms & Conditions for Bidders

- The spares in this tender are required for over hauling of Continental Emsco Swivel LB-500 installed at OGDCL Rig N-4.
- 2. In case, any bidder offers spares from manufacturer other than OEM (M/s NOV), following are required:
 - 2.1 The manufacturer shall have manufacturing experience of at least twenty (20) years. In this regard, bidder to provide business license issued in favor of the manufacturer by the chamber of commerce or any other regulatory authority of the manufacturer's country. The business license (or any other legal certificate) shall reflect date of business establishment, company name and company business brief in English language.
 - 2.2 Bidder to provide company profile of the quoted manufacturer and sale record of swivel parts for last five (05) years by mentioning client names, addresses, e-mails and phone/fax contacts. OGDCL reserves the right to re-confirm the authenticity of provided information in sale record from the clients.
 - 2.3 Bidder to provide copies of minimum three (03) un-priced materialized sale contracts/ purchase orders for supplying adequate quantities (comparable to quantities in this OGDCL tender) of offered swivel spares to different international drilling contractors or drilling companies other than and outside the manufacturer's own country.
 - 2.4 The sale contracts (mentioned above) must bear valid addresses (postal/ e-mail) and phone/ Fax numbers of the end users (customers). OGDCL reserves the right to reconfirm the authenticity of provided contracts/ purchase orders and certificates from manufacturer and end users.
 - 2.5 A certificate from the quoted manufacturer that the offered spares are 100% exact replacement (i.e. 100% compatible in design, dimensions and function/performance) to the spares mentioned in the Schedule of Requirement (SOR) and that no machining or extra work of any type is required to be performed on the spares before installing them in Continental Emsco swivels LB-500.
 - 2.6 Bidders to provide a certificate that in case any part misfits in the mentioned swivel LB-500, same shall be replaced immediately without any additional cost to OGDCL.
- 3. For all offered bearings, bidder to mention in technical bid, bearing manufacturer name, part number & country of origin. Bidder to further provide bearings technical literature, specification, drawing, dimensions and standards of manufacturing.
- 4. In case the bidder offers spares mentioned in the SOR from OEM with superseded / replaced part numbers, these should be clearly mentioned in the technical bid and a certificate from OEM be provided to confirm that the spares supplied with new part numbers are 100% exact replacement (i.e. 100% compatible in design, dimensions and function/performance) to the spares mentioned in OGDCL SOR.
