- 2.3 All the pages of application shall be signed and stamped by applicant's authorized Representative(s).

2.4 Language of Application

The application must be prepared and submitted in English language. Supporting documents and attachments furnished by the applicant must also be in English language.

2.6 Cost of Pre-Qualification.

The Contractor shall bear all cost associated with the preparation and submission of application for Pre-Qualification. OGDCL shall under no circumstances be responsible or liable for such cost regardless of the out-come of the application process.



2.7 <u>Deadline for Submission of Application</u>

- 2.7.1 The original application, together with the required copies must be delivered not later than (as per press advertisement) Hours of dated (as per press advertisement) at the address specified in clause 2.1.
- 2.7.2 OGDCL may extend the deadline for the submission of applications by amending the Pre- Qualification documents in which case all rights and obligations of the OGDCL and applicants previously subject to the deadline will thereafter be subject to the deadline as extended.

2.8 <u>Late Submission of Applications</u>

Any application received after deadline for submission of applications prescribed by the Company pursuant to Clause-2 will be rejected and returned unopened to the Applicant.

Section I. Instructions to Consultants

Clause 1 Consultants must respond to all questions and provide complete information as advised in this document. Any lapses to provide essential information may result in dis-qualification of the consultant.

Clause 2 Clarification:

At any time prior to the deadline for submission of Prequalification/Enlistment Documents, the Client may amend the Prequalification/Enlistment Documents by issuing clarification. Any addendum issued shall be part of the Prequalification Document and shall be uploaded on OGDCL website for all prospective applicants.

The prospective consultants are required to check OGDCL website accordingly and in case of failure of consultant to check website for clarifications, no responsibility shall be at the employer part.

- Clause 3 Evaluation: Consultant's general & particular experience and personnel capabilities, as demonstrated by the Applicant's responses in the prescribed forms will be evaluated as per evaluation criteria given in the document. Sub-consultant's experience and resources shall not be taken into account in determining the consultant's compliance with the qualifying criteria. However, Joint Venture experience & resources shall be considered. Consortium or Association of firms will be considered for similar treatment as in case of Joint Venture. In case of Joint Venture of Consultancy firms all the partner firms are equally liable and responsible. Provision of Joint venture agreement along with responsibility matrix is mandatory.
- Clause 4 Clarification of Prequalification/Enlistment Information: To assist in the evaluation of information, the Client may, at its discretion, ask any consultant for a clarification of any information which shall be submitted within a stated reasonable period of time. Any request for clarification shall be in writing. If any consultant does not provide clarifications of the information requested by the date and time set in the Client's request for clarification then application of the consultant may be rejected.
- Clause 5 Verification of Prequalification/Enlistment Information:

 Verification of the information provided by the pre-qualified/
 shortlisted consultant in the submissions for prequalification may be
 made. In case the information is found to be wrong or incorrect in
 any material way or consultant is found to be lacking in the
 capability or resources to successfully perform the contract, then it
 shall not be pre-qualified.

Clause 6 Other terms for Prequalification/Enlistment:

- i. All the consultancy firms who were pre-qualified/enlisted previously are required to apply afresh. No renewal of previous pre-qualification is admissible.
- ii. Pre-qualification / Enlistment shall remain valid for one year, however, may be extended if required by the employer.
- iii. OGDCL may cancel this Pre-qualification / enlistment and call for afresh enlistment, at any stage.
- iv. Successful applicants will be informed about their prequalification / enlistment through letter as per prevailing policy of OGDCL.
- v. If at any stage any willful commission/suppression of the fact is detected it would be sufficient cause to with draw the pre qualification /enlistment of the firm and to cancel the contract if already awarded.
- vi. Any firm in arbitration or litigation with OGDCL shall be enlisted after arbitration award or decision of litigation in his favor. Having been enlisted, if a firm invokes arbitration or litigation after prequalification, he will be not allowed to participate in next tenders till the award of such arbitration or litigation in his favor.
- vii. Bidders are required to submit all required documents (duly attested) with their application on or before the date and time mentioned in the press advertisement. Application along with required documents shall be delivered on the address mentioned in the press advertisement.
- viii. Failure to provide information / supporting documents that is essential for the evaluation of the applicant's qualification, or to provide timely clarification or substantiation of information supplied, may result in disqualification of the applicant.
- ix. OGDCL may ask any further information and details if required, at any time.
