FOREIGN PROCUREMENT PAYMENT TERMS (COMPETITIVE BIDDING, PREQUALIFICATION AND PROPRIETARY MODE OF PROCUREMENT).

Clause No: 4 of Section-III (Part-B) i.e. Conditions of Contract "Special" of Tender Document has been amended as follows:

Following payments methods have been approved for Competitive Bidding/Press Tender, Prequalification and Proprietary mode of procurement effective from February 27, 2018.

i. **Tender value less than or equal to US\$ 200,000:**

Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 70 % Payment (s) under the L/C will be made for the FOB/ CFR / CPT (as the case may be) price of material of each shipment upon submission of the shipping documents. Balance 30% Payment will be released after receipt, inspection and acceptance of material.

ii. **Tender value more than US\$ 200,000:**

Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 80 % Payment (s) under the L/C will be made for the FOB/ CFR / CPT (as the case may be) price of material of each shipment upon submission of the shipping documents. Balance 20% Payment will be released after receipt, inspection (in addition of pre-shipment inspection) and acceptance of material.

A. TERMS AND CONDITIONS:

1. The OGDCL demanded spares are required for drill pipe spinners, Spinmaster 550-A model, manufactured by M/s Hawk Industries, Inc, USA.
2. OGDCL will consider bids from only those supplier, offering parts manufactured by M/s Hawk Industries.
3. If the bidder is not OEM of offered part(s), a hard copy of authority letter on the OEM letterhead in original must be provided with the bid stating that the OEM has authorized the bidder to offer the parts against this OGDCL tender enquiry. Scanned authority letter or its photocopy will not be accepted.
4. Bidder to inform in advance, if part number(s) mentioned in OGDCL schedule of requirement (SOR) is/are wrong, obsolete or discontinued.
5. Bidder to confirm, immediate replacement of any/all item(s) without any cost to OGDCL, if found misfit/mismatch with main units – Hawk 550/ drill pipe spinner.
6. Bidder to provide along with the proposal/bid, a certificate confirming that all the offered items to be supplied shall be new & unused and recently manufactured (2017 or above).
7. Bidder to provide along with the proposal/bid, standard warranty for the offered units and spares.
8. In financial bid, bidder to mention description, quantity, unit price (FOB), unit price (CFR Karachi) & extended price for each item.
9. OGDCL may increase or decrease quantity of any item at the time of order placement.
10. Delivery period shall be ninety (90) days after establishment of L.C.
11. Bidder to submit signed and stamped copy of OGDCL SOR.
