## 5. Delivery Period

Del very of Water Treatment Chemicals is 90 days after confirmed LC and successful trial run.

## 6. Specific Conditions and Vendor Liabilities for Supply of Water Treatment Chemicals

The company (OGDCL) invites bids from bidders for the supply of different water treatment chemicals in accordance with the terms and conditions listed below:

- Only genuine manufacturers having manufacturing experience of at least 10 years will be considered appropriate for technical evaluation, trade houses and stockiest will not be treated as manufacturers. Bidder must have a local set-up for technical and after sale services in Pakistan.
- 6.2 Bidder shall provide complete details with their technical bid for the shipping, storage and protection of the chemical at H<sub>2</sub>S plant.
- 6.3 Vendor shall guarantee that their supplied chemicals shall fulfill the process requirements as indicated in Clause 2. Vendor shall be liable to identify/provide the details of requirements to meet the requirement provided in Clause 2. Bidder may

quote any additional chemical to achieve the required results which will consider in financial evaluation.

- 6.4 Bidder will have to confirm compatibility of their quoted chemicals with plant metallurgy and their effects on metal to avoid corrosion / leakage/ choking etc.
- 6.5 The quantities mentioned in the tender are for 02 years' requirement and based on average usage of the in-use water treatment chemicals. Dosing rates of each quoted chemicals must be mentioned in bid which is also to be consider in technical and financial evaluation. Bidder may visit OGDCL plant site before quoting chemicals and their experts may give recommendations regarding dosage/usage of their offered chemicals on the basis of water quality control parameter data.
- 6.6 For any newly quoted chemicals which are technically responsive and financially lowest, the vender/bidder will be responsible for conducting free trial run at Dakhni & Qadirpur plants and it will continue till the process official of concerned plants are satisfied and dosage rate is established and performance test is conducted.(maximum two weeks) and will provide indented chemicals for said trial run free of cost also, During trial run bidder will have to achieve required results with their quoted / recommended dosing rates otherwise they will be responsible to provide additional required chemical(s) to OGDCL free of cost. OGDCL may asked to conduct trial run before complete shipment to any of the bidder who previously supplied the same chemicals to OGDCL in order to witnessed the quoted dosing rates.
- 6.7 Before placing purchase order, successful bidder will have to provide complete list of the controlling parameters and their acceptable ranges require analyzing for monitoring the efficiency of dosing chemicals and for smooth plant operations.

## 7. <u>Technical Services:</u>

All technical services provided by bidder should be free of cost described at tender clause 7.1-7.4

- 7.1 Bidder's expert must be available at plant at the time of initial usage of their supplied chemicals till completion of its performance test. This activity includes, but not limited to handling, optimization of dosing rates and to identity the problems and trouble shoot and recommend solution(s) during the activity.
- 7.2 Onsite training of operation and analytical services personnel during activity No 7.1.
- 7.3 Bidder expert may be called at annual turn around his availability for any trouble shooting must be confirmed. Complete lab analysis of sample(s) recovers during shut down activities from cooling towers (annually 03 samples max.)
- 7.4 Perpetual Technical Support.
  - i. Telephonic conversations, no limits
  - ii. Update of new product/development
  - Technical assistance throughout the usage of chemical as and when required at the supplier/vendor expenditures.
