GENERAL TERMS & CONDITIONS.

1. All the quoted spare parts must have the same part numbers as per SOR. In case of different part numbers quoted, OEM to provide letter that the quoted part numbers are exactly the same item as per SOR.
2. All the quoted spares parts must be un-used and should not be older than 01 year. A COC to be provided from the OEM to validate the Manufacturing date.
3. Provision of letter from OEM that the offered parts are genuine and all are exactly compatible to the required spares as per SOR.
4. The Manufacturer will be required to furnish mill inspection certificate for quoted spare parts with shipping documents. Confirmation to this effect must be provided in the offer.
5. Warranty/Guarantee letter for offered spare parts from OEM to be provided for a period of 2 years from date of shipment.
6. Delivery required: - Within (02) months after establishment of letter of credit on C& F Karachi by sea basis.
