## TERMS & CONDITIONS

1. The case will be processed on single stage – two envelop bidding procedure as per PPRA Rules.
2. Bid shall remain valid for a period of 180 Days from the date of technical Bid Opening.
3. Commercial evaluation will be made on complete package. Incomplete bid will be rejected and will not be considered for evaluation. Bidders should quote for all the items in schedule of requirement.
4. The bidders are required to submit a Bid bond amounting to **USD 1000/-** or equivalent Pak rupees in shape of Bank Guarantee/pay Order upfront along with the technical bid. Any bid without bid bond shall be rejected without any right to appeal.
5. Bid Bond shall remain valid for a period of 210 Days from the date of technical Bid Opening. ***Bid Bond from RBS/NIB/SUMMIT Banks is not acceptable.***
6. OGDCL may arrange Third Party Pre-Shipment Inspection at its own cost. TPI Report issued by TPI Firms i.e. SGS/Velosi/Lloyds/TUV Austria shall be the Part of Shipping Documents.
7. Within ten (10) days of the receipt of notification of intent to award the Contract from OGDCL, the successful Bidder shall furnish a Performance Bond in the Form of Bank Guarantee (**Attachment-03**) for an amount of US\$ ten (10) percent (%) of the Contract Price as a guarantee for the due and faithful performance of the Contract. The said Performance Bond shall be valid upto Twelve (12) months from the date of shipment.
