## 3. <u>EFFECTIVE DATE OF CONTRACT.</u>

The TSS Agreement will commence from 09<sup>th</sup> March 2019.

## 4 ORACLE TECHNICAL SUPPORT SERVICES

The successful Contractor will be required to arrange Oracle Technical Support services for supported licenses from Oracle Corporation as follows:

- i. Program updates, fixes, security alerts, and critical patch updates.
- ii. Tax, legal, and regulatory updates.
- iii. Upgrade scripts.
- iv. Major product and technology releases, which includes general maintenance releases, selected functionality releases, and documentation updates.
- v. Assistance with service requests 24 hours per day, 7 days a week.
- vi. Access to Oracle Support (24 X 7 web-based customer support systems), including the ability to log service requests online, unless stated otherwise.

- vii. Program updates, maintenance and functionality releases, document updates, bug fix and patches.
- viii. Any other services covered in Technical Support Services.

## 5. <u>BIDDING PROCEDURE.</u>

- i. The procedure for bidding will be Single stage two envelope procedure, containing separately technical and financial proposals.
- ii. Technical Proposals will be opened first and evaluation will be carried out by a Technical Evaluation Committee. The proposals not qualifying in technical evaluation will be rejected and financial proposal of the respective firm will be returned un-opened.

## 6. <u>TECHNICAL EVALUATION.</u>

- i. Bidders must be Oracle GOLD Partner or above.
- ii. Bidders must attach the Oracle Partner Certificate with Technical bids, otherwise rejected.
- iii. Bidder must be providing arranging above mentioned services in Pakistan for at least 05 Years.

- i. The prices must be quoted in PKR.
- ii. Bid price shall be inclusive of all taxes, duties, levies, charges etc., except Provincial Sales Tax (PST)/ Islamabad Capital Territory Sales Tax (ICT)in Pakistan.
- iii. The prices quoted by the successful bidder (contractor) for required services shall remain firm and final throughout contract period. The price charged by the successful bidder (contractor) for required services shall not vary from the prices quoted by the service company.
