## 1.0 OVERVIEW

OGDCL is using Barracuda Email Security Gateway (BAR-SF-400) for incoming/outgoing mail traffic that filters the traffic and blocks junk mail as well as virus infected mails. The device is a combination of Hardware and Software and works effectively to control junk mail and viruses on emails.

This device was installed at OGDCL Datacenter in 2007 and its instant replacement option was purchased in 2014. This device works like an anti-virus program that constantly gets updates from its manufacturer's website to effectively block junk mail and new viruses. This update facility becomes available on paying an annual maintenance (called energize updates and Instant Replacement).

Proposals are invited through Open Competitive Bidding from Bidders that can arrange undermentioned licenses along with hardware/software support services from manufacturer for 03 years.

#### 2.0 SCOPE OF WORK

The detail of licenses to be provided by bidder is as under:

- Licenses should include Signature Updates for Spam, new and legacy Viruses and Security Updates for Operating System beside Major Firmware Upgrades for the next 03 Years starting from 28-Feb-2020.
- Renewal of manufacturer's hardware\software support for the next 03 Years starting from 28-Feb-2020.
- Appliance based License solution should not charge per user license fees.

# 3.0 EFFECTIVE DATE OF CONTRACT

The effective date of Agreement for both items at Sr#1 & 2 is from 28-02-2020.

## 4.0 SUPPORT SERVICES

The successful bidder will be required to arrange Technical Support services for supported licenses from Barracuda Networks as follows:

- a. Program updates, fixes, security alerts, and critical patch updates.
- b. Major product releases, which includes general maintenance releases, selected functionality releases etc.
- c. Assistance with service requests 24 hours per day, 7 days a week.
- d. Access to Barracuda Networks Support by establishing connection to Barracuda Support Center (24 X 7 web-based customer support.
- e. Firmware updates, maintenance and functionality releases, bug fixing and patches.
- f. Any other services covered in Technical Support Services.

## 5.0 BIDDING PROCEDURE

- a. The procedure for bidding will be Single stage Single envelope procedure, containing separately financial and technical proposal.
- b. Technical and Financial Proposals will be opened at the same time. Evaluation committee will evaluate the bids according to the technical and financial criteria given at clause 6.0 and 7.0 respectively.
