- 8. The Contractor will be responsible for movement of the personnel to pick and drop point of Rig (Mob/demob).
- The Contractor will provide proper uniform to the personnel as per oil industry standards for these services.
- The rate running contract will initially be for two years and can be extended further on mutual consent based on performance basis.
- 11. The bidders will also attach the contract record of such services provided at Oil & gas Companies.
- 12. The bidder(s) will provide the NTN registration with bid.
- 13. The bidder will have sound financial record and proof will be provided.
- 14. The bidder will provide last 03 years financial audited report.
- 15. The bidder will ensure that its quotation is complete in all respects such that OGDCL is able to perform a complete and meaningful evaluation.
