- 6. All submitted bids will be evaluated strictly on the basis of previous performance / supply record, failing which will lead to disqualification.
- 7. All attachments as per Claus (C) must be submitted with technical bid.
- 8. Supplied material will be accepted after physical inspection and lab analysis in OGDCL on-site laboratory.
