TERMS OF REFERENCE (TOR)

1. Registered Firms / Companies doing Transportation business in Pakistan and having their self-owned office premises, are invited to quote their competitive rates for hiring of following categories of vehicles having all safety provisions, as per international safety standards, on the routes given in the Tender Documents for daily pick & drop facility to the OGDCL employees of Rawalpindi/Islamabad, to its offices located Blue Area Islamabad through a fleet of 25 (Twenty Five) passenger vehicles(with driver + Fuel) (Zero Meter / 2011 or Up model) of Toyota Coaster / Hiace (Hi Roof), Suzuki Bolan etc, only with Petrol / Diesel fuel(CNG fitted not allowed), as per detail given below:

2. The interested companies / firms may submit their Financial Bids with following requisite documents:

- Complete business location with phone, fax and e-mail / postal addresses. (i)
- (ii) More than 06 years' experience of pick & drop services with at least 03 renowned companies/ organizations.
- (iii) Detail of available registered vehicles with the firm (quoted) {At least 25 vehicles(Coaster, Hiace/Van) must be registered in the name of firm
- Companies with more than 25 (Twenty Five) million Annual Turn-over (less may not apply). (iv)
- NTN Registration Number with Income Tax Certificate. (v)
- (vi) Bank Statement (last 03 years).
- (vii) List of reputed clients.
- Undertaking on non-judicial stamp paper to the effect that the firm has never been blacklisted by any (viii) Government / Semi-Government Department and that all the offered vehicles have Fitness Certificate from Motor Vehicle Examiner.
- (ix) Bid Bond for a sum of Rs. 2,000,000/- shall be required with Technical Bid.
- OGDCL reserves the right to reject any/all bids without assigning reason. (x)
- (Xi) The firm must be registered with their current Provincial Sales tax deptt.

3. The bidder/contractor should provide rates for the various routes as per follows:-

i. The bidders are requested to provide rates for the routes from A-1 to A-25 of Annex A, for all the vehicles based on fuel cost as per existing per liter cost of Fuel(Diesel/Petrol (Altron)), in such a way that they should quote per kilometer rates for the total 1790 KMs mileage to be covered each day (Form "B" may be filled as per schedule of requirement attached as Appendix- A). The difference cost (+- Rs.10/- per liter) of Fuel shall be adjustable proportionate to the variation in fuel price during the period of contract (Existing rates: HSD is 127.3 & Petrol is 116.6).

(The difference cost (+- Rs.10/- per liter) of Fuel shall be adjustable proportionate to the variation in fuel price during the period of contract" means that either any increase of fuel prices by Rs.10 or decrease by Rs.10 from the base price of fuel mentioned in TOR, neither OGDCL will pay any nor any deduction from the monthly bill of the contractor will be made. However, if the fuel prices increase or decrease beyond these levels, the difference of cost will be paid as per the daily consumption of each vehicle.

For example: :-Base price of Fuel (as per Agreement) is) @ Rs. 127.3 (+/- 10) for HSD. No extra payment will be by OGDCL if HSD price increase up to Rs. 137.3 & no amount will be deducted from contractor payment. If it reduced to Rs. 117.3 . However if fuel price increase or decrease beyond these level, then the difference cost will be adjusted as per following formula:-

- If HSD rates at the start of month reaches Rs.147.3
- Difference cost: Diesel (HSD) : (147.3) (137.3) = 10 Rs
- Let a vehicle has daily mileage of 80 km & its daily consumption is 10 litres HSD(vehicle Average 8Km/litre
- As per Formula:-
 - Difference of fuel(+-10) × (total fuel consumption of vehicles as per their average) x No of days/month $(10) \times (10) \times (22) = Rs. 2200$ (for one vehicle) will be paid by OGDCL)
- Further if fuel price decreases beyond the mentioned level, deduction will be made from contractor by the same method.
- ii. Vehicle at Sr#25 is required for 24 Hrs. Bidder should quote rates for 22 days/month as per 100 Kms daily running, however monthly payment will be made as per actual running, noted at the end of month(which will be verified by the concerned department)
- iii. All the vehicles are required for 05 working days/week (22 working days/month).
- iv. Average fuel consumption of each vehicle type will be considered as : Toyota Coaster AC : 06 KM/litre, Toyota Coaster

Non AC: 07 KM/litre, Toyota Hiace AC: 07 Km/litre, Toyota Hiace Non AC: 08 Km/litre), Suzuki Bolan: 15 Km/litre,

- v. CNG fitted vehicles are not allowed.
- vi. The quoted rates must be inclusive of all kind of taxes except Provincial sales tax.
- vii. Payment will be made to the contractor ,on monthly basis ,against verified invoices.



- 4. The Model of vehicles to be provided to OGDCL must be 2011 or up.
- 5. The contractor must ensure to reach the shift within office timings. However ±10 minutes delay due to traffic problem or any reason shall be exempted. If the shift reaches late more than 10 minutes, Rs.500/-per day will be charged by the Company.
- 6. The quoted rates must have the validity for a minimum period of 180 (One Hundred Eighty) days from the date of submission of the Financial bid.
- 7. Contractor will ensure to complete its routes, in case of failure Rs. 5000/- per day per vehicle will be deducted from invoice.
- 8. The successful bidder shall also furnish 10% PGB of the contract value within 15 days of issuance of LOI.
- 9. The successful bidder shall also provide the Reg books of all the vehicles to be deputed on each route of Annex-A, at the time of agreement (<u>All the Vehicles Must Be Registered in the Name Of Bidder/His Firm</u>). In case the vehicles provided by bidder being purchased through Bank leasing, the bank agreement with the bidder and other related documents for the vehicles must be provided.
- 10. The Contract shall initially be executed for a period of <u>02 (two) years</u>, which can be extendable by the mutual consent of both parties on same terms and conditions.
- 11. In case of problem in the hired vehicle, Contractor will ensure to provide alternate vehicle for uninterrupted pick & drop to the employees of the company otherwise a sum of Rs.5,000/- per day will be deducted till such time the alternate / proper arrangement are made by the contractor.
- 12. Any route can be altered to the extent up to 05 KM's as and when required due to transfer/posting/shifting of any employee without any increase in the hiring charges.
- 13. In case any toll tax involves on any route, the same will be paid by the contractor, however it can be reimbursed from OGDCL at the end of month.
- 14. The quoted rates shall be evaluated on package basis (Full Consignment wise).
