

Oil & Gas Development Company Limited TERMS OF REFERENCE (TOR)

1. Firms/Companies registered with the relevant authorities doing transportation business in Pakistan and having their self-owned/rented office premises, are invited to quote their competitive rates for hiring of following categories of vehicles having all safety provisions, as per prevailing safety standards, on the routes given in the Tender Documents for daily pick & drop facility to its offices located in RO, Karachi, KBS, KDS, West Wharf and Medical Centre Karachi through a fleet of 24 (Twenty Four) passenger vehicles (with driver and Fuel), as per details given below:

- 2. Any offer not received as per terms & conditions of the tender is liable to be declared with-responsive. No offer shall be considered if:
 - a. Received without bid security.
 - b. It is received after the time and date fixed for its receipt in Press Tender Notice.
 - c. Not signed & stamped by authorized person on each page of the bid.
 - d. The offer is received by fax or e-mail.
 - e. The offer is from a black listed firm on OGDCL/PPRA or any other authority's website.
 - f. The offer is not conforming to specifications indicated in the tender documents.
 - g. Any additional terms & conditions added by the Firm.
 - h. Any conditional offer.
- 3. Bid will remain valid for a period of 180 days from the date of opening the tender. Contract will be enforced initially for a period of 02 years which may be extended with mutual consents of both parties for another one year (Client and Firm) as admissible by PPRA.
- 4. The bidder must be the owner of the Company / Firm having at least 24 owned vehicles that should specifically be Hiace model 2010 & above. Rental agreements for ownership of vehicles will not be considered in the total count. The bidder must provide copies of registration books to confirm the ownership.
- 5. The interested companies / firms may submit their Bids with following requisite documents:-

- i. Complete business location with phone, fax and e-mail / postal addresses.
- ii. Minimum 05 years' experience of pick & drop services with renowned companies/ organizations having contract of at least 14 vehicles (i.e Hiace). (Agreements should be attached).
- iii. At least 24 vehicles (Hiace/ Hi-jet) must be registered in the name of firm (Detail of any other vehicles will not be considered in the total count of technical evaluation).
- iv. Companies with more than 20 (Twenty) million Annual Turn-over should participate (less may not apply).
- v. NTN and GST/PST Registration Number with Certificate.

- vi. Audited Accounts (last 03 years).
- vii. List of reputed clients (Agreements should be attached).
- viii. Undertaking on with-judicial stamp paper to the effect that the firm has never been blacklisted by any Government / Semi-Government Department and that all the offered vehicles have Fitness Certificate from Motor Vehicle Examiner.
- ix. Bid Bond for a sum of *Rs. 2,000,000/-* shall be required with <u>Technical Bid</u>.
- x. OGDCL reserves the right to reject any/all bids without assigning reason.
- xi. The firm must be registered with their current Provincial Sales tax deptt.

- i. Duly filled and signed Form B with rates
- 6. The bidder/contractor should provide rates for the various routes as per follows:
 - i. The bidders are requested to provide rates for the routes from A-1 to A-24 of Group-A, for all the vehicles based on fuel cost as per existing per liter cost of fuel (Petrol /Altron), in such a way that they should quote per kilometer rates for the total 2681 KMs mileage to be covered each day (Form "B" may be filled as per schedule of requirement attached as Group-A. The difference cost (+- Rs.10/- per liter) of Fuel shall be adjustable proportionate to the variation in fuel price during the period of contract. (The difference cost (+- Rs.10/- per liter) of Fuel shall be adjustable proportionate to the variation in fuel price during the period of contract" means that either any increase of fuel prices by Rs.10 or decrease by Rs.10 from the base price of fuel mentioned in TOR, neither OGDCL will pay any nor any deduction from the monthly bill of the contractor will be made. However, if the fuel prices increase or decrease beyond these levels, the difference of cost will be paid as per the daily consumption of each vehicle.)
 - ii. All the vehicles are required for 05 working days/week (22 working days/month), detailed attached schedule of requirement. However the working days may vary and the actual payment shall be made as per actual working days.
 - iii. Average fuel consumption of each vehicle type will be considered as: Toyota Hiace : 07 KM/litre, Suzuki Hijet : 12 KM/litre,
 - iv. CNG fitted vehicles are not allowed.
 - v. The quoted rates must be inclusive of all kind of taxes except Provincial sales tax.
 - vi. Payment will be made to the contractor, on monthly basis, against verified invoices.
- 7. The contractor must ensure to reach the shift within office timings. However, ±15 minutes' delay due to traffic problem or any reason shall be exempted. If the shift reaches late more than 15 minutes. Rs.500/- per day/ per vehicle will be charged by the Company.
- 8. Contractor will ensure to complete its routes, in case of failure Rs. 5,000/- per day per vehicle will be deducted from invoice.
- 9. In case of problem in the hired vehicle, Contractor will ensure to provide alternative vehicle for uninterrupted pick & drop to the employees of the company otherwise a sum of Rs. 10,000/- per day will be deducted till such time the alternate / proper arrangement are made by the contractor.
 - 10. The successful bidder shall also furnish 10% PGB of the contract value within 15 days of issuance of LOI.
 - 11. The successful bidder will be given at least one (01) month time after execution of agreement to provide registration books of all the vehicles to be deputed on each route as per Group A. In case the vehicles provided by bidder being purchased through Bank leasing, the bank agreement with the bidder and other related documents for the vehicles must be provided.
- 12. In case of problem in the hired vehicle, Contractor will ensure to provide alternate vehicle for uninterrupted pick & drop to the employees of the company otherwise a sum equal to per day rental will be deducted till such time the alternate / proper arrangement is made by the contractor.

- 13. Any route can be altered to the extent up to 05 KM's as and when required due to transfer/posting/shifting of any employee without any increase in the hiring charges. Above 5 KM OGDCL will pay as per governing rules of the contract.
- 14. In case any toll tax involves on any route, the same will be paid by the contractor.
- 15. The vehicles must be equipped with fire extinguisher, first aid kit, seat belts, spare wheel, essential tool box etc.
- 16. Driver health certificate is also required.
- 17. The contractor/bidder will be responsible for maintenance of the vehicles throughout the contract period.
- 18. The quoted rates shall be evaluated on package basis (Full Consignment wise).
