# **TERMS OF REFERENCE (TOR)**

## Introduction

OGDCL is soliciting Proposals from qualified organizations that can provide Internet Connectivity solution for the OGDCL House Islamabad for a contract period of 3 years.

# Scope of Work

- 1. Defining the solution requirements to deploy and commission Internet Connectivity over optical fiber at the OGDCL Head Office in Islamabad.
- 2. Bidder should have their own optical fiber network.
- 3. Bidder shall arrange all the components required for the project.
- 4. Upon successful service commissioning, testing would be commenced for 3 days.
- 5. Service contract would be signed by both parties before commissioning of the services.
- 6. The Internet services will be hired initially for 03 years from the date of signing of contract; however, these services can be extended with mutual consent.
- 7. Successful vendor will be responsible for integration of internet service up to OGDCLs enterprise network.
- 8. Successful vendor will be responsible for:
  - a. Ensuring 99.5 % uptime
  - b. Ensuring end to end Premium circuit connectivity
  - c. Managing inventory of installed hardware
  - d. Smooth maintenance and operation
  - e. Troubleshooting
  - f. Monitoring live internet traffic patterns via MRTG
  - g. 24/7 availability

# Invitation to bid

OGDCL intends to hire the services of a qualified Internet Service Provider to provide internet connectivity at its Head Office in Islamabad for a contract period of 3 years. Reputed Firms / Companies providing internet services are requested to submit their sealed bids.

The proposed solution should be devised keeping in view the following guidelines:

- a. Redundant/Highly available; based on vendor's own fiber network
- b. Support 24/7/365

The selected firm will supply, install, configure, test & maintain equipment (Fiber ODF/ONT) for internet connectivity. The selected firm will also be responsible for implementing the technical architecture of the project.

The selected firm is expected to use the international 'best practices' in delivering the services within time, cost and quality. Maintenance and complete services will have to be provided by Service Provider during contract period.

The successful firm will be responsible for:

- a. Supply of hardware
- b. Complete Installation/Commissioning of Internet Connectivity along with related components
- c. Smooth and timely User Acceptance Testing
- d. Provision of 8 Public IPs

#### **General Instructions to the Bidders**

- 1. The proposal is to be submitted in a single envelope, including technical and financial proposals.
- 2. Name and contact Address (email and phone numbers) of Project Manager who will be responsible for responding to queries if any in the BID.
- 3. The qualification marks for qualifying in technical bid are at least 70%.
- 4. Financial bids of only those firms will be opened who will qualify in technical bids evaluation. Financial bids of non-qualifying firms will be returned sealed.
- 5. The lowest financial bid will be awarded with contract.

# **Eligibility Criteria / Mandatory Requirements**

- 1. Bidder must be in the business of providing internet and well as managed services to offer turnkey solution for complete enterprise network.
- 2. Must be incorporated in accordance with Pakistan Laws for at least **6 years**, registered with PTA for provisioning of internet.
- 3. Must be at least **Tier 2** internet service provider.
- 4. Must have valid NTN number & Sales Tax number and must not have been blacklisted by any of Provincial or Federal Government Department, Agency,

- Organization or autonomous body or Private Sector Organization anywhere in Pakistan. (Submission of undertaking on legal stamp paper is mandatory.)
- 5. Must have its own deployed, commissioned, managed and operational Fiber network. (PTA certificate required.)
- 6. Must be capable of providing onsite support of the WAN link and enterprise devices (routers/switch) of multiple platforms as and when required.
- 7. Must possess its own optical fiber based last mile infrastructure with direct fiber connectivity on CPE (e.g. media convertor/ONT).
- 8. Must have their NOC being commissioned in their own premises.
- 9. Must provide 24/7/365 technical support over telephone.
