- 1- Spare parts required under this tender will be used in maintenance and repair/replacement of the explosion proof receptacles installed at OGDCL Rig N-5 and N-6. Original equipment manufacturer (OEM) of these plugs/ receptacles is M/S RG Inc., CHINA.
- 2- The required spare parts are to be supplied from manufacturers or their authorized dealers/ distributors only.
- 3- If the spare parts are to be supplied from a manufacturer, a hard copy of authority letter from manufacturer issued in favor of the bidder (as per Clause-5) must be provided with the bid proposal
- 4- If the spare parts are to be supplied from authorized dealer/ distributor of a manufacturer, a hard copy of authority letter/ dealership certificate from manufacturer issued in favor of the dealer and authority letter issued by the dealer in favor of the bidder (as per Clause-5) must be provided with the bid proposal.
- 5- For bidders other than manufacturers or their authorized dealers/ distributors, a hard copy of authority letter from manufacturer or authorized dealer/ distributor of the manufacturer (as the case may be) in favor of the bidder must be provided with the bid. Such authority letter must have the following features.
 - i. Printed on the letterhead of manufacturer or authorized dealer/ distributor of manufacturer.

- 6- For manufacturers other than OEM (M/s RG Inc., CHINA) following will be required.
 - i. Minimum fifteen (15) year experience in manufacturing of the plugs/ receptacle's spare parts. Bidder to provide documentary proof with the bid proposal in this regard.
 - ii. Sale record for last five (5) years showing supply of EX- plugs/ receptacles spare parts to various oilfield installations/ oil companies/ oil and gas drilling companies.
 - iii. Copies of minimum three materialized purchase orders/sale contracts showing supply of adequate quantities of EX- plugs/ receptacles (comparable to this tender) to various oilfield installations/oil companies/oil and gas drilling companies other than and outside the manufacturer's own country.
 - iv. Certificate from the quoted manufacturer that the offered equivalent parts are 100% compatible with the parts mentioned in schedule of requirement of this tender enquiry and, in case any part is found incompatible with the existing EX- plugs/ receptacles at OGDCL rigs, same will be replaced immediately without any additional cost to OGDCL.





- 7- Bidder to offer the required spares with complete description, part number, technical specification and quantity. Moreover, the required spares to be supplied complete in all respect, ready to use by the end user without need for any alteration etc.
- 8- Bidder to confirm that the offered items will be supplied new, unused and free from all manufacturing defects.
- 9- Adequate and relevant manufacturer's literature for the offered spares must be provided with the technical proposal to facilitate technical evaluation.
- 10- In case, the bidder offers any of the required items with superseded/ replaced part number, this should be clearly mentioned in the technical bid that offered items with new part number(S) is/are 100% exact replacement (i.e. 100 % compatible in design, dimensions and function/performance) to the items mentioned in the schedule of requirement.
- 11- Bidder to mention in financial bid the description, quantity, unit price (FOB), unit price (CFR) & extended price.
- 12- The offered spare parts to be covered by the manufacturer's warranty against misfit/incompatibility, defects in material and workmanship and bad performance.
