TERMS OF REFERENCE (TOR)

FOR BOPS REPAIR, SERVICING & TESTING

THE SCOPE OF WORK

- 1. Repair the BOP and its pressure testing (replacing the seal parts, repairing the groove, function test, pressure test)
- 2. OEM overhaul and recertification. (optional)
 - Contract will be for a period of 01 year.
 - OGDCL will provide all spare parts which will be needed during BOP service.

GENERAL INSTRUCTIONS FOR THE BIDDER

- 1. OGDCL Intends to carry out repair, servicing and testing of various well control equipment.
- 2. After award of Contract to successful bidder, Well Control equipment will be sent to designated workshop. Equipment will be repaired, services and pressure tested.
- 3. The bidder will have established base/warehouse with sufficient tools inventory/back up for BOP in Pakistan along with pressure testing facility.
- 4. The bidder will be holding the API-Q1, API-6A, API-16A certificate.
- 5. The bidder will have OEM authorized workshop, the OEM will be one or more of the list, GK, Hydril, Rongsheng, Shenkai, Shaffer, Control Flow or Cameron. (mandatory)
- 6. The bidder must have more than two qualified welder from OEM mentioned at Sr # 5.
- 7. The bidder shall provide the workshop service.
- 8. The bidder shall have more than five (05) years' experience of workshop service and on-site service about BOP.
- 9. The workshop shall equipped with the following facility, Pressure Test system (including recording, monitoring system), hydraulic torque wrench, digital controlled lathe, drawing bench, horizontal hydraulic drawing bench, etc.
- 10. The bidder shall have the back-up BOP for emergency situation (mandatory).
- 11. Bidder shall give separate quotation for each BOPs.
- 12. The bidder shall have track record of providing workshop service about BOP for E&P companies in Pakistan for last 03 years.
- 13. The bidder shall have ability and experience to perform remanufacturing/overhaul and recertification as OEM requirement.
- 14. The bidder shall implement the BOP repairing relevant standard operating procedures, HSE management regulations.
- 15. OGDCL will be responsible for the following:
 - a) Providing necessary clearance and transport for shifting BOPs from OGDCL yards up to the workshop within Country.
 - b) Unloading / Loading of BOPs at contractor yard / workshop will be responsibility of the contractor

- 16. Contractor will be responsible for the following;
 - a) Proper handling of units at their facility
- 17. Payment of the services performed will be made in PKR after the job against verified invoices on submission of workshop inspection and testing reports.
- 18. OGDCL professional will visit the workshop from time to time.
- 19. Bidder will submit a weekly progress report to OGDCL of the job in progress.
- 20. Evaluation criteria will be on a lump sum basis.
