### Hiring Services for Supply of Prepaid Satellite Phone Connection with Scratch Cards/Soft Pins through Two years Rate Running Contract

#### **Overview**

The Company intends to hiring services for supply of Thuraya prepaid Satellite phone connection with Scratch Card/soft Pin for its remote locations through two years' contract.

Vendors having required expertise, resources and similar work experience are invited to submit their proposal as per detailed requirements given in this T&C.

## SCOPE OF WORK

Bids are invited for rate running contract of Two years for Supply of 40 Thuraya prepaid Satellite phone SIM cards/connections with one-year initial validity and 10 US \$ initial credit limit along with 350 scratch cards/Soft pin of 50 units each.

Bidder will provide initially 29 prepaid Satellite Phone Connections/SIMs and 174 scratch Cards/soft pins of 50 units each to OGDCL immediately after issuance of Contract/PO and remaining 11 prepaid Connections/SIMs and 176 scratch cards/Soft pins of 50 units each will be provided as and when required during contract period on same rate.
