Kindly clarify how the LIH rates should be quoted as there's a discrepancy between the following documents: <ul style="list-style-type: none"> • Notes for Rate Format in ITT – LIH required for each tool in the rental list • Revised Rate Format – LIH Required in the lump sum format 	As mentioned in serial No.1 and 3
5	Clarification No. 2 Article No. 13 & 14	Page 2 of 3	It has been mentioned in clarification request no. 2 that if redress and circulation rates are quoted for NMDC and string stabilizers then they will be considered in financial evaluation calculation. Kindly clarify the financial evaluation criteria against which redress and circulation rates of NMDC and string stabilizers will be evaluated as no numbers are mentioned in the redress and circulation rates for NMDC and string stabilizers in section A, B & C of the financial evaluation criteria.	If any bidder quotes the rates of circulation and redress for NMDC and stabilizer for all sections then circulation time will be same as for other tools and quantity of redress will be 1.
6	Revised Rate Format (Clarification No. 1)	Section C (Page 4 of 5)	Kindly clarify the evaluation criteria for Article 5 (6" Integral Blade Stabilizers) in Section C as no numbers have been mentioned for operating days, standby days, circulating time or redress quantity.	It is mentioned that in case of 6"/5/7/8" hole, 6" stabilizers operating days will be 10 days and standby days will be 01 day.

11			Need well diagram for Directional well and for performance job showing at least section lengths, logging requirements, drilling days expected and hazards anticipated for each section	It will be provided after selection of the contractor
12			Both the directional drilling jobs and the performance drilling jobs require RSS correct? Because usually performance drilling jobs don't require RSS and are done with Straight motors?	As per tender documents
13			Document states that bidder must provide proof of sufficient quantity of RSS tools "for 2 concurrent directional and 2 performance drilling jobs using RSS at different locations at the same time for same hole sizes" – Kindly clarify if COMPANY expectation here is for presence of qty of tools for 2x concurrent jobs same section same time or 4x concurrent jobs same section same time?	It is clarified that one job of same size of the hole will be carried out at the same time.
14			Please confirm understanding that Bypass circulation sub is a single cycle circulation sub?	As per industry practice
15			Confirm that LWD services will not be part of the financial evaluation as per the financial evaluation criteria they have been left out.	As per tender documents
16			What LWD services if any are required in each section?	As per requirement of the well
17			Please clarify when is the redress charge applicable?	It depends upon utilization of the tool
18			When is the Expected commencement / start date of the contract?	After completion of formalities
