TENDER ENQUIRY NO. PROC-SERVICES/CB/PE&FD-4116/2018

HIRING OF ENGINEERING CONSULTANCY & PIPELINE SUPERVISION SERVICES

Reference to subject Tender Enquiry, following clarifications have been made in the subject tender:

1. Refer Page 26 of 47, heading no.8 "Boarding, Lodging, Transportation etc." it is mentioned under accommodation clause that " *Boarding & Lodging as per suitable arrangement would be on account of OGDCL head at site location / field.*"

However, under Food/ Messing clause on same page it is mentioned:

" Food will be provided to the contractor's professionals at field from respective messes in which they will be accommodated on payment of Rs. 750 per day (mess charges of three meals a day) on account and cost."

We understand that the boarding, lodging of ZEL Personnel at OGDCL's site shall be on OGDCL's account, kindly confirm.

REPLY: OGDCL will charge the personnel at the daily rate, this would not be on part of OGDCL account as per revision. Kindly note.

2. Refer Scope Wise Work Packages (page # 17, 18) & Financial Table (page # 28) of tender document, kindly clarify the below:

On page # 17, Group-1 scope, Part A, it has been split in A1 & A2, kindly clarify what is the difference between A1 & A2 works.

REPLY: The deliverable as per tender are different for the two sub groups A1 and A2. Kindly note.

3. On page # 17, Group-1 scope includes 10 km pipeline survey/design, and in Financial Table the quantity of Group-1 is mentioned as 12 Jobs. Therefore, we understand that the total pipeline scope is $10\text{km} \times 12 = 120 \text{ km}$, kindly confirm.

REPLY: Confirmed

4. On page # 18, Group-2 scope includes as-built of 30km of pipeline and 20 well heads, and in Financial Table the quantity of Group-2 is mentioned as 8 Jobs. Therefore, we understand that the total as-built work is as follows:

- Total Pipeline as-built = $30\text{km} \times 8 = 240 \text{ km}$, kindly confirm.
- Total Wellheads as-built = $20 \times 8 = 160 \text{ nos.}$, kindly confirm.

REPLY: Confirmed as above.

5. For work packages Group-1 & Group-2, kindly provide the specific locations where these works are needed. In Financial Table, quantity of Group-1 jobs are 12 nos. and quantity of Group-2 jobs are 8 nos., kindly let us know the locations for these works so that we can estimate the cost of survey.

REPLY: As per TENDER, and OGDCL nature of operations across Pakistan; locations or region scan not be identified, as replied in the first web corrigendum as well.

Kindly NOTE that for Group 3 & 4, PEC requirement is not valid and evaluation criteria would be based on the qualification mentioned in the Group details (e.g. submission of 3 or 5 or seven CV, 25 years' experience, PMP certification etc.) is sufficient. The qualification for Group 3 & 4 would be page 19 of 47 of the tender ONLY.
