Reference to the Annexure-A, Technical Specification, Bioremediation System, please clarify the Bioremediation facility where Bioremediation treatment process will takes place, utilities and arrangement required to keep the bioremediation facility operational, likewise Power Supply/ Power Generator, Watchmen, accommodation and food for crew and fuel for machinery / power generator shall be arranged by the contractor or provided by	The contractor would be responsible for all the arrangement at Bioremediation facility. OGDCL will, however, provide the land only for carrying out the cuttings treatment.
