3	Reference to the same as Point#2, if in case of 1TB, please clarify the scope of work, Locations, Quality for which bidders shall submit the technical and financial proposal accordingly.	No financial Proposal is required; as it is only a Pre-Qualification. Interested companies are requested to provide the documents required for Pre-Qualification as mentioned in TOR (i.e. Annexure A) and in Pre-Qualification/Technical Evaluation Criteria Clause 8 of Annexure A.
4	In continuation of point#3, please advise the financial bid format which shall use for financial evaluation.	Same as above; no Financial proposal is required.
