1	<p><b>Clause # 4.1(iv)(c):</b> Regarding OGDCL Clarification No. 1 (Sr. # 3), that Testing of electrical, instrumentation and rotary equipment is out of the scope of this contract, we understand that module for EIRMS is not required in the software to be offered to OGDCL.</p>	Please see clarification NO.1
2	<p><b>Clause # 4.1(v)(b, d &amp; e):</b> We understand from these clauses that an interface is required (for these activities) to integrate with Maximo or any other CMMS System. Normally this is done for a long term projects and not for a short term project of 2 Years because it will increase cost and will take time for software developer to develop interface. Kindly clarify whether it is required or not?</p> <p>Further to above if OGDCL need web based software then we understand that there is no need to develop interface.</p>	<p>Please ref: para 4.1 (V) (b, d &amp; e) Requirement of software, OGDCL is already using Maximo and further details available in TORs in above mentioned paras.</p> <p>Web bases software will be preferred.</p>
3	<p><b>Clause # 4.2(iii) &amp; Financial Evaluation Criteria (Sr. # 11)</b> It is mentioned in Clause # 4.2(iii), that to Carry out RBI Assessment of remaining plants (Specially Uch-II, KPD, Sinjhoru, Dakhni, Nashpa, and Chanda) which makes it 5 Plants along with their feeding wells, gathering facilities. But as per Financial Evaluation Criteria (Sr. # 11), costing is required lump sum for 3 Plants. Kindly clarify.</p> <p>Further to above, we need total number of equipment's/assets i.e. piping, pipeline, pressure vessels, storage tanks of each plant for competitive &amp; accurate costing. Otherwise it will be assumption based costing, which can go on a higher side.</p>	<p>Costing will be as per financial format of OGDCL's TOR.</p> <p>We can't provide you quantified number of equipment's / assets piping, pipeline, pressure vessels and storage tanks at this time.</p>
4	<p><b>Financial Evaluation Criteria (Sr. # 1 to 13)</b> We need total number of equipment's/assets i.e. piping, pipeline, pressure vessels, storage tanks for competitive &amp; accurate costing. Otherwise it will be assumption based costing, which can go on a higher side.</p> <p>Regarding Financial Evaluation Criteria (Sr. # 10) i.e. Data Compilation &amp; review for Other Fields such as Maru-Reti, Nur-Bagla, Chaknaurang, Kal, Sadqal, Fimkassar, Rajian etc., we need to clear that whether these all fields/plants are included or OGDCL requires quote for one of them. The total becomes 7 fields against this.</p>	<p>Estimated quantity / fields is already provided in Our TOR's.</p> <p>A lumpsum cost is required for all mentioned fields.</p>
5	<p><b>Clause # 4.9</b> As per this clause, The AIMs contractor shall also be required to provide training to nominated company professionals through a qualified, certified and well experienced</p>	Trainer's qualification shall be as per TOR

6	<p><b>Financial Evaluation Criteria (Sr. # 16)</b></p> <p>“Prepare QA / QC plans and review PQRS for new fabrication works (for pipelines, storage tanks, Pressure Vessels)”, from this we understand that costing is required per each storage tank or per each pressure vessel. Kindly clarify for piping also, how we will determine its quantity for costing. Will it be per tag or per certain minimum length?</p>	<p>The estimated quantity is available in financial format of OGDCL’s TORs</p>
7	<p><b>Financial Evaluation Criteria (Sr. # 14)</b></p> <p>As per API 579-1/ASME FFS-1, there are three Assessment levels of FFS based on criticality i.e. FFS Level-1, 2 &amp; 3. Every three levels have different approach and accordingly different costing, especially when it comes to cracks evaluation we even go for Level-3 Assessment using Finite Element Analysis (FEA) Software, which has a higher cost than FFS Level 1 &amp; 2 Assessment.</p> <p>Kindly clarify above. We suggest to give costing against FFS Level-1, 2 &amp; 3 separately to OGDCL.</p>	<p>As per financial format of OGDCL TORs please.</p>
8	<p><b>General (Group A)</b></p> <p>Considering above and the extensive scope of work for Group A, we need more time for better understanding of OGDCL Plants/Assets and consequently for a market competitive pricing to better serve OGDCL Technically and the same time commercially in the field of AIM.</p> <p>For that reason we request OGDCL to extend 15 Days in the deadline of tender submission.</p>	<p>Since services are required urgently and an appropriate time has already been given for preparation, therefore the request for bid extension is regretted.</p>
