2	<b>Format for Rates Coiled Tubing Section Page 11 of ITB – Point# 1 and 3:</b> Require "CT Crew" and "Coil Tubing Complete crew for all Categories PCE".	Clarification on the difference of these two items is requested from OGDCL - which one to be filled-in?	Both are same as such you can quote Serial # 01 of format of rates only.																																								
3	<b>Format for Rates Pumping Services Page 11 of ITB – Point# 26:</b>	No operating of pumping equipment is required in table of format and is mentioned as N/A; only standby is required. However, pumping equipment operating needs to be filled in Table A of financial evaluation model. Clarification on reference pertaining to the operating cost of pumping unit is requested.	At serial # 26 of format of rates; you've to quote both standby as well as operating rates of different pumping equipment (detail given). <b><u>N/A is a typing mistake in operating rate column of serial #26.</u></b>																																								
4	<b>Financial Evaluation Model Table B Page 16 of ITB:</b>	Daily rates of some pumping services equipment (e.g. acid transfer pump, batch mixer, c-pump etc.) are requested in Tables A & B while the same have been requested in format of rates with operating & standby charges. Please clarify which number (operating or standby) to be considered for the daily charges requested in Table A & B.	In Table A, operating & standby charges of pumping equipment are segregated. However, in Table B; only operating charges of pumping equipment from serial # 14 to 21 to be quoted for evaluation.
