Also, the required number of jobs are quite high for any local/regional company, who could be capable of performing as professionally as any international company but didn't had chance to provide the services on these many jobs, therefore we would request to please reconsider and remove the required number of jobs because the 3rd point of the same evaluation criteria is covering the required experience in the shape of minimum jobs/year. By doing this the local/regional companies can participate positively in this process for obtaining the best and competitive pricing in the interest of Nation.
