### TENDER ENQUIRY NO. PROC-SERVICES/CB/LOG-4910/2020 AGAINST HIRING OF SERVICES FOR MONITORING OF TRACKER DEVICES & FUEL LEVEL SENSORS INSTALLED IN OGDCL LOGISTICS VEHICLES

One of the Prospective bidders has made a query against the subject Tender Enquiry. The query along with OGDCL replies is given below for information of all the prospective bidders.

01	Please re-confirm & mention in the Tender Document that the Quoted Price will be Exclusive of Provincial Sales Tax (PST).	Bid Prices shall be inclusive of all applicable duties, levies and taxes etc. except PST/ICT where applicable will be borne and paid by the Company at actual.as per Tender /TOR.
02	Please clarify if New Tracker Device is to be provided for installation under this Item. Thus, it should be written as “New Tracker Device (Including Installation Charges).”	In financial format item at S#1, Yes, New tracking devices to be installed.
03	Please clarify if New Fuel Level Sensors Devices is to be provided for installation under this Item. Thus, it should be written as “New Fuel Level Sensor Device (Including Installation Charges).”	In financial format item at S#2, Yes, New fuel level sensors to be installed.
04	This right away deduction is unjustified. Deduction of amount is requested to be associated with the actual ground reality and should be proceeded after thorough Joint Investigation Report by a Team of Head Office, Camp Office & Contractor.	Read TOR page#2/6, Item S#5 (Kotsarang and Tando Alam fields), it is clearly mentioned monitoring services charges <u>inclusive after sales services for 02 years period.</u> Since OGDCL is paying for after sales services for 02 years period, therefore, contractor must depute proper service team. If after sales services is not provided properly by contractor, OGDCL has right to deduct amount per day for errors/disfunctions.
05	Bidder must have 60% Marks in each Category (Pen written  The above-mentioned pen writing condition is in contradiction with the condition of the contract where “Bidders obtaining less than 70% Marks will be disqualified” is mentioned.	Refer to page#3/6 of TOR, Technical Evaluation Criteria S#1 to S#15, <u>No contradiction</u> , bidder must obtain 60% marks in each category, to provide/meet minimum 60% requirement of each S#1 to S#15, and must obtain 70% marks out of total 100 marks for said requirements.
06	Please allow to quote this one-time unavoidable cost to be part of the contract.	Already mentioned in TOR, supplier will provide the trial run of compatible software at Kotsarang and Tando Alam fields vehicles at his own cost.

07	Please allow to quote this one-time unavoidable cost to be part of the contract.	Already mentioned in TOR, supplier will provide the trial run of compatible software at Kotsarang and Tando Alam fields vehicles at his own cost. Bidder will also provide after sales services for 02 years period for which OGDCL is paying.
08	recurring cost of REDO per device per visit may please be allowed to be payable in cash at the respective OGDCL Camp Office.	Supplier will provide the trial run of compatible software at Kotsarang and Tando Alam fields vehicles at his own cost and Monitoring services per device per month charges inclusive after sales services for 02 years period cover this query.
09	To transfer the tracker and/or sensor from one vehicle to another vehicle this item may please be added to the financial format of the Tender Document.
