#### **TERMS AND CONDITIONS:**

1. Tyres are required for the Hydraulic crane, having following specification:

Make Tadano Model TL-300E Capacity 30 Ton

- 2. Manufacturing date of tyres should not be older than 06 months from the date of issuance of purchase order.
- 3. Supplier must provide complete information about manufacturer and certify that tyres are of genuine quality and as per required specifications. Tyres will be inspected aat site before acceptance. Warranty period on tyres should be mentioned
- 4. The supplier /bidder should have minimum of 5 Years of past experience for supply of same nature of material.
- 5. Documentary evidences i.e purchase orders for similar nature of material must be provided with the Technical Bid.
- 6. Completion certificate / performance certificates of previous clients must be attached.
- 7. Delivery period for material is 02 months from the date of issuance of Purchase order.
- 8. Single stage, single envelop bidding will take place along with full consignment evaluation criterion for the bids.
- 9. Bid bond should be of value PKR 40,000/-.
- 10. Payment will be made through cross-check and payment will be released when after inspection and acceptance of material.
- 11. Supplier to provide all necessary documents like Annex-C (Tax), professional tax certificate etc. with invoice.

- 12. The material will be delivered at Dakhni Plant, the delivery charges to Dakhni gas processing plant to be borne by the supplier / bidder.
- 13. The variation in quantity at the time of order placement will not change the unit cost of material.

  Moreover quantity of tyres can be changed after bid opening keeping in view unit rate of tyre for adjustment in tender limit.
- 14. OGDCL reserves the right to increase or decrease the material quantity in the SOR without assigning any reason thereof.
