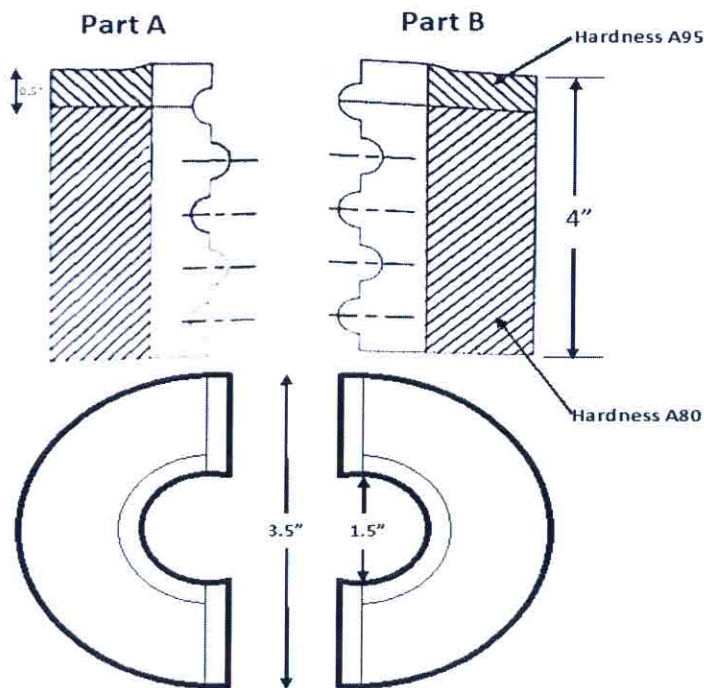

2. Only FBR registered bidders can submit their bids having NTN & STRN.
3. Bid bond for an amount of Rs. 120,000/- (Rupees one lac and twenty thousand only) would be submitted by the bidder at the time of bid submission in favor of **Operation Manager Logistics Field, OGDCL, Kotsarang Talagang**.
4. The quotes will be opened on the date & time as mentioned in the tender notice. The bidder can send his representative to Base.
5. Item must be brand new and not refurbished.
6. Successful bidder will be responsible for provision of entire consignment as per specifications of web tender at **Cementation/ Stimulation Base /Logistics Field, Kotsarang, Talagang** within 21 days after award of Supply order.
7. Material will be accepted after the inspection & evaluation by committee of OGDCL Cementation base at Logistics Field Kotsarang.
8. On receipt of the consignment, if it is found short consignment, substandard after use, then the supplier shall have to lift the entire rejected consignment and replace the substandard material with the material conforming to the tender specifications at his own cost within Fifteen (15) days.
9. Performance Bank guarantee i.e. 10 % (Excluding GST, PST/ICT or any other indirect applicable taxes by the Govt.) of the PO (Purchase order) value would be submitted by the successful Bidder.
10. The Manufacturer/Bidder firm must provide copies of two (02) Purchase orders.
11. The payment shall be made through cross Cheque/online after inspection report submitted by OGDCL committee.


