1. <u>INTRODUCTION</u>

- g. Technical information/experience of the company of similar Project.
- h. Details of relevant experience since at least last two years/profile of the company.
- i. Latest audited financial statement since at least last one year.
- j. Bank certificate regarding the history of bank account opening and overall financial stability of the bidder.
