

OGDCL invites sealed quotations for the shifting of Seismic Party No.02 from Gwadar-2D (Dist. Gwadar, Baluchistan to Sujawal South-3D (Dist. Sujawal, Sindh). The distance between the locations is about 760 KM (One Side).

# **Bidding Method**

Bids against this tender are invited on single stage, single envelope bidding procedure.

## **Terms & Conditions:**

- 1. The scope of work can be increased or decreased and payment will be made to the contractor as per actual work done against verified invoices.
- 2. Tentative schedule for start the shifting of <u>Seismic Party NO 02 is in the beginning of September 2021</u> however written notice for mobilization (within a week) will be served by OGDCL Party Chief. Contractor will provide list of cranes and trailers prior to move.
- 3. The contractor will be responsible to provide HSD to the Cranes and Trailers. Further, the pull & push, boarding/lodging & all kind of maintenance, oil/tyre change will be the responsibility of the contractor.
- 4. Any damage of OGDCL material during shifting through private trailers is the responsibility of contractor. The contractor will pay the loss/ repair the material assessed by OGDCL officials.
- 5. The contractor shall ensure that the papers of vehicles (Registration, road permit and regulatory requirements, tax & pollution/ annual fitness certificate from regulatory authority etc. are complete in accordance with government laws.
- 6. Contractor shall be responsible for violations of traffic rules & misconduct of drivers. OGDCL have the right to demand replacement of a driver/helper in case of misconduct/ illegal activities or repeated violation of traffic rules.
- 7. The firm should mention experience in shifting in term of number of Seismic Party/Rigs shifted. Furthermore, OGDCL reserves the right to verify the performances of the bidder
- 8. If shifting delays due to any reason attributed to bidder then OGDCL can charge penalty up to 10% of the total amount.
- 9. Contractors are bound to obey OGDCL security rules/ movements during the shifting in the security alert areas.
- 10. The Firm should submit an affidavit attested with notary public along with the application to the effect that firm/ directors or partners are not black listed by any

other organization as per format provided in master set of tender document services annexure "F".

- 11. The Contractor shall be liable to pay all Government levies, taxes and incidentals such as toll tax, etc.
- 12. Quoted prices must inclusive of all applicable taxes, duties such as all taxes, levies, toll charges, fuels, lubricants, etc. Except PST/ICT tax on services in Pakistan
- 13. The bid must be validity is required for 180 days from technical cum financial bids opening.
- 14. Copies of document of trailers and cranes to be submitted with bid.
- 15. In case of JV, JV agreement stating responsibility of each partner and name of lead partner must be clearly mentioned in agreement and JV agreement must be attached with the bid.
- 16. Duration of project is two weeks from issuance of mobilization notice.

<u>Mandatory Requirement</u>: If the bidder failed to fulfill all the mandatory requirement, then their bid will not be considered for further evaluation.
