2. The bidder may be represented by a local agent within Pakistan as per clause no. 27 of OGDCL's Tender Document, but should not involve any third party in the bidding.
3. Only Genuine Parts should be quoted against the indented spares. Aftermarket parts are not acceptable.
4. The indented spare parts are required for the CAT 3406 ENGINES.
5. In case a replaced part number quoted, instead of existing part no. as per Schedule of Requirement then supporting documentation from Caterpillar must be provided.
6. Parts must be in original OEM Packing.
7. Parts must be new & free from any defect.
8. If bidder found any ambiguity in part nos., it should be cleared prior to bid opening date.
9. Parts must have standard OEM warranty/guarantee.
10. Delivery period 90 days after PO issuance.
11. Bidder quoting equivalent parts must be provide a certificate from at least three well renowned / E&P companies of foreign jurisdiction other than bidder/ manufacture own country, stating that equivalent (quoted parts) are used by them and performance of such parts is found satisfactory. Copies of purchase orders (unpriced) must also be provided. The certificates /seal record is mandatory and due to non-submission thereof, the bid will be rejected.
12. Evaluation criteria: Full consignment wise on CFR Karachi basis.
