Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 70 % Payment (s) under the L/C will be made for the CFR / CPT, price of material of each shipment upon submission of the shipping documents. Balance 30% Payment will be released after receipt, inspection and acceptance of material.

### ii. Tender value more than US\$ 200,000:

Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 80 % Payment (s) under the L/C will be made for the FOB/ CFR / CPT (as the case may be) price of material of each shipment upon submission of the shipping documents. Balance 20% Payment will be released after receipt, inspection (in addition of pre-shipment inspection) and acceptance of material.

# SCOPE OF SUPPLIER FOR 80KVA UPS

This document covers the scope of work for the supply of industrial type UPS, 80 KVA for main facility of UCH II Plant. The Supplier shall be responsible for onsite supervision of installation and complete testing and commissioning of the offered UPS system.

The Supplier shall be responsible for all the works included but not be limited to the following:

- Supply of UPS system as per Specifications mentioned in schedule of requirements (SOR) including all the necessary equipments whether specifically mentioned or not in the specification & datasheets but are required for proper operation.
- The Supplier shall provide the technical details, general arrangement drawings, battery bank general arrangement details/ layouts, battery bank dimensional drawings, battery sizing calculation sheets, battery sizing load profile, installation details and all the relating documents as specified in document.
- The offered UPS system shall be internally pre-wired.
- The Supplier shall provide parallel kit and battery bank along with the UPS. Battery banks shall be enclosed in a separate cubicle/ cabinet.
- The supply of main power cable from MCC/ Switchgear to UPS, power and control cables from UPS to battery banks and battery chargers shall be in scope of OGDCL.
- All other interconnecting/ interface cables, batteries interconnecting cables required for UPS
  package shall be in Supplier's scope.
- The Supplier shall be responsible for onsite delivery and transportation of supplied equipment and associated equipment & material.
- The responsibility of the Supplier also includes the supervision of installation and complete testing and commissioning of supplied UPS system.
- It is the responsibility of the Supplier to ask for witness and approval from OGDCL for the supervision of installation and complete testing and commissioning of UPS system at site.
   The supplier shall keep the records of the protocols and submit the copy of the same to the OGDCL.



- The Supplier shall submit the Factory test plan at least 30 days prior to the test for OGDCL's review and approval. The Supplier shall also be responsible for SAT and submit the SAT plan to the OGDCL. The Supplier shall be responsible to have all the necessary tools and equipment available at the time of SAT.
- The Supplier shall provide the dimensional details for the offered UPS system.
- The Supplier shall submit the procedure for installation, interconnection and commissioning prior to installation.
- Personnel engaged in electrical installations shall be fully qualified and competent tradesmen skilled in the particular activity in which they are engaged.
- Deviation and exception shall be clearly specified by Supplier at the bidding stage.
