1. INTRODUCTION

3. TERMS & CONDITIONS

Eligibility Criteria for Travel Agencies/ Companies:

- i) The bidders should be registered with tax authorities & incorporated with SECP.
- ii) The bidders must be engaged in the industry for a minimum of 2-4 years
- iii) The bidders should be having enrolment number of hajj ministry.
- iv) The bidders should preferably have office at Islamabad/Rawalpindi.
- v) The bidders should preferably have Munazzim number with KSA.
- vi) Copies of relevant certificates/documents/licences to be provided with bid.



4. Methodology

The Firm shall use an acceptable Systematic Methodology to carry out its activities and prepare all conclusions and recommendations with supporting documentation.

Term of Reference should confirm strict compliance to all aspects/requirements.
