Bidder understand that "0258-PB-2111 REV-0 Sheet 2 of 2 (Plot Plan for Fire Water Ring System TAY-3 GGS)" is only valid for fire water network. Equipment placement will be follow as per 0258-PC-2205-2 (PLOTPLAN TAY-03 GGS). Please confirm.	Confirmed.
4	Bid Bond Validity	As per SEC-II (Instructions to Bidders), 210 days Bid Bond validity required whereas "Invitation to Bid Sheet 6 of 11" in note 11 required bid bond validity of 240 days. Company to clarify this discrepancy.	Bid bond validity is 210 days.
