In compliance of tender requirements, a pre-bid meeting at OGDCL House (Islamabad) was arranged by OGDCL on December 1st, 2021. Prior to this meeting, a pre-bid site visit was also arranged by OGDCL for the prospective bidders (participated by M/s. AJC/HBP, M/s. Jereh/Petrocon and M/s. Elite Engineering along with OGDCL/ENAR personnels) on November 23rd, 2021. Following are the minutes of the referred meetings;

S. No	Description		
Pre-	re-Bid Meeting (01 st December,2021)		
1	A bidder asked regarding the basis of tender format. OGDCL/ENAR clarified that tender document was prepared in accordance with the PPRA, PEC by laws and OGDCL standard format. However, specific requirements w.r.t. project have been mentioned in tender documents, wherever required. Also, it was advised that bidder may raise any specific query in writing w.r.t. the subject.		
2	In response of a bidder query w.r.t. security arrangements, OGDCL stated that security arrangements shall be considered by the bidder as per requirements mentioned in tender document (specifically in Sec-11.11 of CoC).		

3	It was re-iterated by OGDCL/ENAR (as already stipulated in tender document) that any exceptions/deviations from the Tender by bidder shall be submitted as 'separate' section i.e. Deviation (Minor) Form (Annexure-VII) in the bid proposal. Any discrepant / conflicting statement (if any) of the bidder's bid proposal mentioned elsewhere in any document will stand 'null and void' and accordingly will not be considered at any stage of technical evaluation of project.
	Also, bidder shall be responsible to submit correspondence evidence with the selected Packager/OEM of the turbo-compressor package in the bid proposal w.r.t. exceptions/deviations to the tender document and compliance obtained by the bidder against each exception/deviation.
4	Furthermore, it was informed by OGDCL/ENAR that bidder shall submit duly signed and stamped true translation copies of relevant documentary evidences of 'Eligibility Requirements' as per SEC-II_ITB Clause-1.5 (if other than in English language) verified from notary public of country of origin along with original copy, as per tender requirements.
5	It was informed by OGDCL/ENAR that bidder shall submit Project Completion Certificates in bid proposal, duly signed and stamped by respective Clients, as per tender requirements.
Pre-	Bid Site Visit (23 rd November,2021)
6	During Pre-bid Site Visit, it was informed (already mentioned in SEC-III Scope of Work) that double block & bleed and positive isolation for early tie-ins shall be provided during plant shut down. Also, plant shutdown will be advised by OGDCL.
7	Upon requirement of drawings for dismantling & relocation of diesel storage tank with pumps, it was informed by OGDCL/ENAR that relevant drawings (Rev. IFC) shall be shared with bidders for 'works estimation purpose only'. However, bidder shall conduct site visit to gather any 'as-built' information for carrying out complete detailed engineering works for the subject matter.
8	Also, it was clearly conveyed to the bidders that piping plans in tender document are of 'conceptual' level and for estimation purposes only. Moreover, It is the responsibility of successful bidder for carrying out complete engineering of the piping route and tie-in locations during detailed engineering stage.
9	In response of a bidder query w.r.t. utilities arrangement for Construction Contractor, it was informed that bidder shall be responsible for the arrangement of necessary utilities (as per SEC-III; Sec-13.0)
