2. The material will be delivered at Bettani Oil and Gas Field. The delivery charges to Bettani Oil Field to be borne by the supplier/ bidder.
3. Any required technical clarification/details regarding material to be supplied must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.
4. Bidder shall have to provide Catalogues/Brochures of the offered brands.
5. All material shall be inspected on delivery for quality and workmanship on delivery. If found unsatisfactory then supplier shall have to replace the same within a week.
6. Unbranded/refurbished/Counterfeit items shall not be acceptable.
7. Material will be accepted after final inspection at site, and payment will be made through OGDCL Head Office.
8. The firm should have valid NTN and GST number and have active status on FBR website.
9. The Firm should have active Professional tax certificate of concerned Excise office where operating business.
10. Tax submission Certificate (Annex-C) will be provided along with Invoice.
11. Bid evaluation will be as per complete Supply of Material.
12. The supplier should have prior experience of supply of these material. Renowned manufacturer to be quoted.
