TERM OF REFERENCE

FOR

HIRING OF BULLDOZERS & EXCAVATOR FOR SULEMAN-2D PROJECT

SCOPE OF WORK:

OGDCL is operating with its 05 Nos. owned Seismic Crews. Purpose of this tender is to acquire services for hiring of bulldozers and excavator to meet the requirements of OGDCL for Suleman 2D project in District Zhob, Loralai and Musa Khel on as and when required basis for a duration of fifteen (15) months (further extendable with mutual consent on same rates and terms & conditions). The contractors are required to submit their details and willingness to provide Bulldozers as mentioned in below table and work with seismic crew of OGDCL.

Financial Rate Format: -

Bidder will quote rate strictly as per following format: -

The bidder shall provide Bulldozers with operators at the rates/hour. These rates shall be inclusive of all taxes duties and fees of whatever nature except PST/ICT tax which will be paid/ reimbursed by OGDCL at actual where applicable. This rate shall remain fixed and firm for subject contract. One side mobilization will be provided by the Bidder and one side will be borne by the OGDCL.

Based on the Oil Industry seismic operations crew assignments, the bidder should never be defaulter before or black listed. Contractor must have previous experience related to seismic culture of about 06 month or more.

Terms & Conditions

1. The bidder shall supply defect free, well maintained Bulldozers.
2. Bidder shall provide skilled operators for the Bulldozer ("Operators") who shall be of good conduct and health. All operators shall possess valid licenses to operate Bulldozers.
3. The Bidder shall provide to OGDCL a copy of the computerized national identity card along with complete residential address of each of the operator.
4. The Bidder further undertakes that each and every operator whose services are provided by him is not a drug addict and has never been convicted of an offence involving moral turpitude.
5. Bidder shall be solely liable to pay all salaries, benefits and costs associated with the supply of Bulldozer or services and shall indemnify OGDCL for any claim in this regard.
6. The Bidder shall be responsible for boarding and medical facilities of his personals.
7. OGDCL shall only provide accommodation in tents to the Contractor's personnel. No messing shall be provided by OGDCL.
8. Only HSD shall be provided by OGDCL, all other lubes and filters shall be responsibility of contractor.
9. Only one single/ double cabin shall be provided for pick & drop of operators and mechanics for work site by OGDCL.
10. The OGDCL may also ask the contractor to replace any bulldozer that is not well maintained, frequently breaks down or is not fit for the purpose for which it is retained. The contractor shall replace such Bulldozer at their own cost and risk, within three days of OGDCL notice. Failure by contractor to do so shall relieve the OGDCL for making any further payments.
11. Payment shall be made at actual in the name of the bidder through cross cheque only at the end of each month against verified invoices. No cash payment is allowed. Bidder is bound to provide the dozers within one week after issuance of LOI, otherwise, LD will be charged as per clause # 12 of draft contract.
12. Bidder must have at least one bulldozer extra so that in case of break down or any other issue, the spare bulldozer can put in service in order to save time.
13. Contract will be immediately effective from the date of issuance of LOI by SCM department.
14. Bidder must read, understand and duly signed and stamp all the pages of TOR.
15. OGDCL may depute officers for pre inspection of workshop/machinery. If the workshop/machinery found by the committee is not satisfactory in any aspect, then the bidder will be considered as technically non responsive.

17. Bidders must comply to OGDCL HSEQ policies, in case of any incident happened on field, causing any sort of damage to men power or machinery, sole responsibility will be on the bidder.
18. No standby charges will be paid in any case.
