- 2) EVALUATION CRITERIA: FULL CONSIGNMENT WISE ON CFR KARACHI BASIS.

- 4) **SHIPMENT FROM ACU MEMBER COUNTRIES:** IN CASE OF SHIPMENT FROM ACU MEMBER COUNTRIES, THE LC BENEFICIARY SHOULD BE OF THAT PARTICULAR COUNTRY FROM WHERE THE CONSIGNMENT IS BEING SHIPPED.

BALANCE 30% PAYMENT WILL BE RELEASED AFTER RECEIPT, INSPECTION AND ACCEPTANCE OF MATERIAL.
- 8) **TENDER VALUE MORE THAN US\$ 200,000:** PAYMENT TO THE CONTRACTOR/ BIDDER IN FOREIGN CURRENCY SHALL BE MADE BY ESTABLISHING IN FAVOR OF THE CONTRACTOR AN IRREVOCABLE LETTER OF CREDIT (HEREINAFTER CALLED THE L/C). 80 % PAYMENT (S) UNDER THE L/C WILL BE MADE FOR THE FOB/ CFR / CPT (AS THE CASE MAY BE) PRICE OF MATERIAL OF EACH SHIPMENT UPON SUBMISSION OF THE SHIPPING DOCUMENTS. BALANCE 20% PAYMENT WILL BE RELEASED AFTER RECEIPT, INSPECTION (IN ADDITION OF PRE-SHIPMENT INSPECTION) AND ACCEPTANCE OF MATERIAL.

TERMS & CONDITIONS FOR BIDDERS

1. The bidders to provide original authority letter of the manufacturer or their authorized dealer / distributor on their letter head.
2. The manufacturer to have at least **20 years'** experience of manufacturing dead line anchors for wire line size 1-3/8 inch against OGDCL tender enquiry number. (Documentary proof will be required). Copy, photo copy or scan documents will not be accepted.
3. Bidders to provide **valid API-8C** certificate consecutive for the **last 15 years**.
4. Bidders to submit previous sale record of selling such Dead line anchors to other oil companies with name, contact / fax numbers & e-mail addresses.
5. In case the bidder offers dead line anchor with equivalent part numbers, it should be clearly mentioned in the technical bid & a certificate to be provided by the manufacturer that offered dead line anchor is 100% exact equivalent (i.e. 100% compatible in design, dimensions and function/performance) to the one mentioned in the Schedule of Requirement.
6. **Technical Specifications for the required Dead line anchor, Model: HA131-T**
 - i- Rated dead line pull: 100,000 pounds.
 - ii- Wire line size: 1-3/8 inch
 - iii- Compatible with Load sensor Type: Tension (E-80)
 - iv- Mounting: Orientation: Base
 - v- Grade 8 Bolts: 4 -2"
7. Bidder will confirm that offered dead line anchor with will be new & unused.
8. The dead line anchor should be boxed & packed in compact manners to ensure safe transportation during shipment.
9. Delivery period will be 90-120 days after establishment of L.C.
