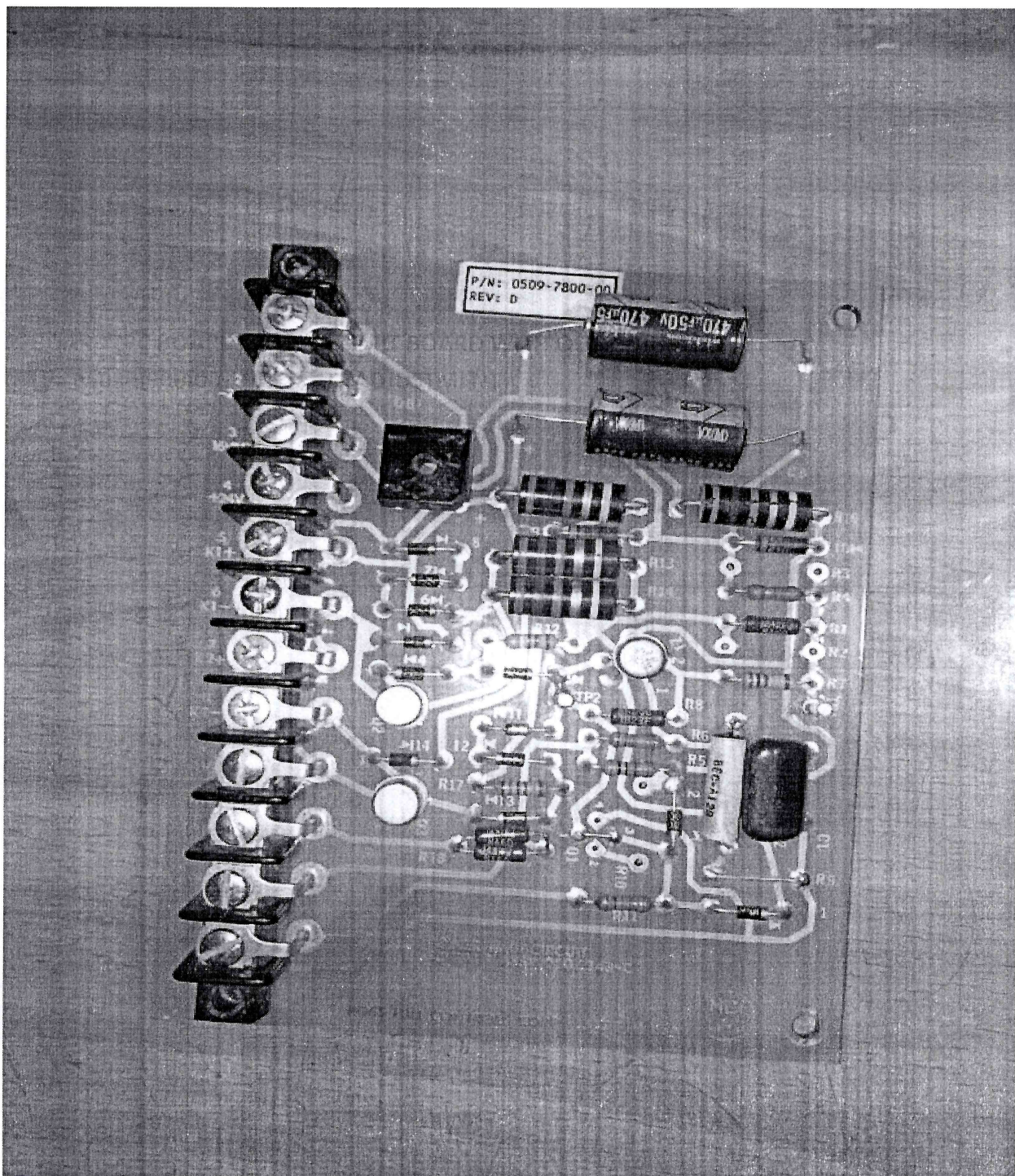

TERMS & CONDITIONS FOR BIDDERS

- 1- The required spare parts are to be supplied from OEM (M/s National Oilwell Varco) or their authorized dealer/ distributor only.
- 2- For bidders other than OEM, a hard copy of authority letter from OEM/ OEM authorized distributor must be provided with the bid. Such authority letter must have the following features.
 - i. Printed on the letterhead of OEM or authorized dealer/distributor of OEM.
 - ii. Submitted with the technical bid in original.
 - iii. Duly signed and stamped by the OEM or authorized dealer/distributor of OEM as the case may be.
 - iv. Bearing OGDCL tender enquiry number.
 - v. Stating that OEM/ OEM authorized distributor (name to be mentioned) has authorized the bidder (name to be mentioned) to offer the spare parts against this tender enquiry and that genuine, new and unused spare parts will be supplied free from any defect .
 - vi. Scanned authority letter or its photocopy will not be accepted. OGDCL reserves the right to confirm authenticity of the document from the issuer.
- 3- Bidder to offer the required spare parts with complete description, part number and quantity. Moreover spare parts to be supplied complete in all respect.
- 4- Adequate and relevant OEM literature for the offered spare parts must be provided with the technical proposal to facilitate technical evaluation of the proposal.
- 5- Bidder to mention in financial bid the description, quantity, and unit price (C &F by air, Islamabad airport) & extended price.
- 6- The spare parts (PCBs) should be as per pictures attached (Page No.2, 3 & 4).
- 7- The offered spare parts to be covered by the OEM warranty/ guarantee for a period of one year from date of installation or 18 months from the date of shipment. Bidder/ Supplier will immediately replace defective spare part (PCBs) free of cost during the period at no additional cost to OGDCL, whatsoever.
- 8- Quantity of the required spare parts may be increased or decreased as per OGDCL requirement.
- 9- Delivery period: 120 days from the date of establishment of LC.

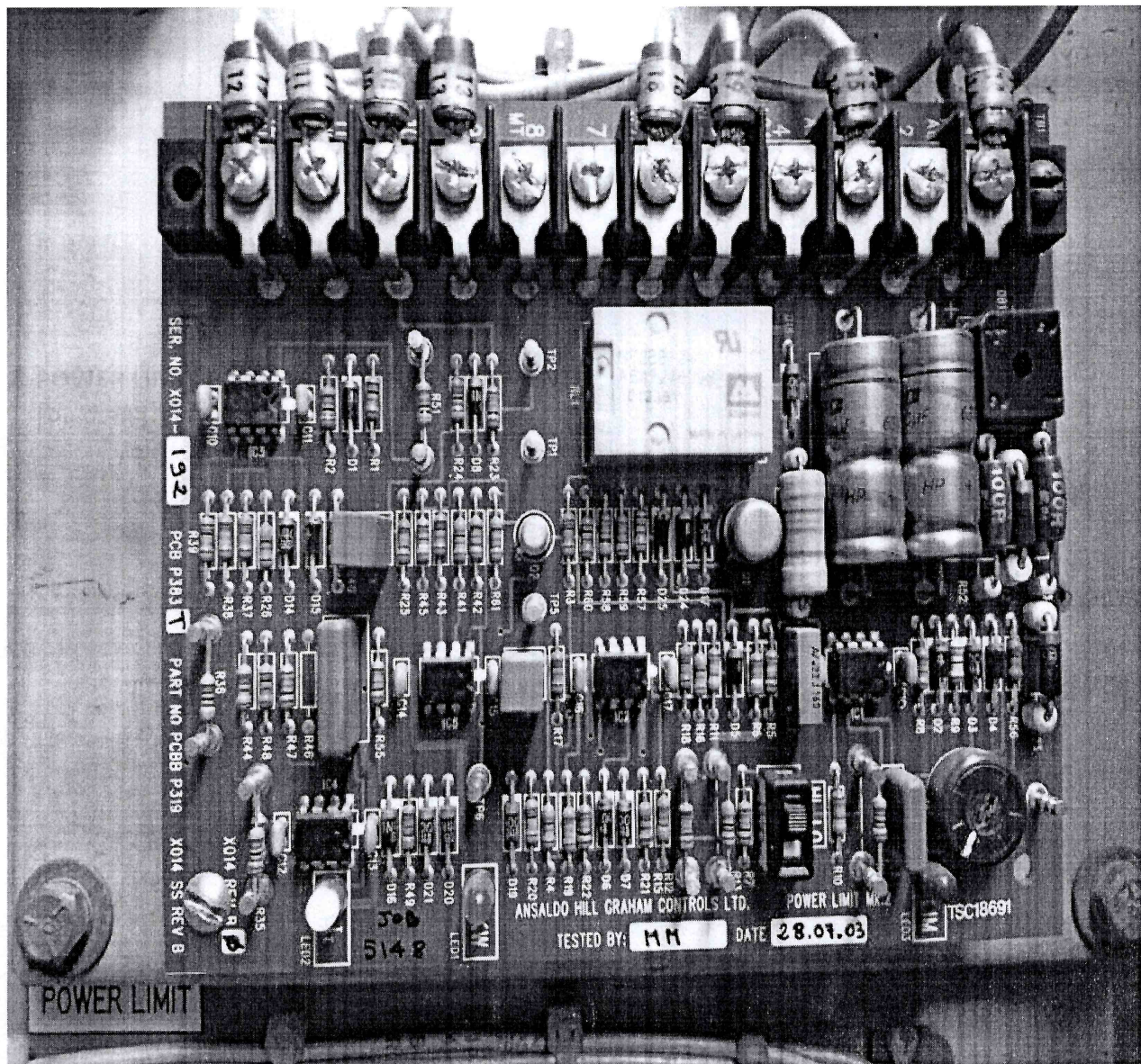
